ORDINANCE OF THE CITY COUNCIL OF JACKSON, MISSISSIPPI AMENDING SEC. 102-31 OF THE SIGN ORDINANCE ADDING THE EXEMPTION OF DEFINED CHURCH (PLACE OF WORSHIP) WITH EXISTING GROUND SIGN STRUCTURE.

**WHEREAS**, it is in the best interest of the City of Jackson to exempt Churches with an existing ground sign from applying for a permit or variance to change the face of the sign.

WHEARAS, the City Council of Jackson, Mississippi recognizes that existing churches may change institutions either through Lease, purchase or acquisition. In addition the City Council understands that an institution defined as a church (place of worship) has the right and authority without a sign permit or variance to change the face of existing ground sign to represent the name of the place of worship.

WHEREAS, a church (place of worship) is defined as a facility used to hold religious services, meetings, and similar activities. The term church shall not carry a secular connotation and shall include buildings in which the religious services of any denomination are held. The term church does not apply to detached accessory uses or church related uses such as schools, residences, coffee houses, day care centers, bingo parlors, and fellowship halls.

**WHEREAS**, this ordinance does not apply to store front or newly built churches (places of worship). This ordinance only applies to existing churches where there is already a defined existing ground sign.

**BE IT HEREBY ORDERED** that the city council amends Sec. 102-31 of the sign ordinance adding the following:

(25) Church (Place Of Worship) with an existing ground sign.

**IT IS FINANLY ORDERED** that the preceding amendment of the referenced Ordinance of the City of Jackson, Mississippi shall be published and effective immediately upon passage.

### ORDINANCE AMENDING SECTION 2-168 OF THE JACKSON CODE OF ORDINANCES - CITY EMPLOYEE WAGE REQUIREMENTS. (ALL WARDS)

WHEREAS, the public health, safety and welfare of the citizens of the City of Jackson shall be considered by this Ordinance; and

WHEREAS, the adjustment in minimum wage for the employees of the City of Jackson is timely; and

WHEREAS, the adjustment of the minimum wage in the City of Jackson to Fifteen Dollars (\$15.00) per hour will make the City of Jackson's pay structure in line with the minimum wage of many employers.

#### NOW, THEREFORE, BE IT ORDAINED as follows:

SECTION 1. Section 2-168 of the Jackson Code of Ordinances is amended as follows:

Unless contrary to federal, state or local law:

- (1) Effective October 1, 2020, minimum hourly wage for city employees, excluding participants of the 2015 Mayor's Summer Youth Employment Program, shall be \$15.00.
- (2)—An-annual incremental hourly wage increase of \$0.95-shall-be-made-for two consecutive years and shall be made effective at the beginning of each fiscal year as follows:
- \_\_\_\_\_a. Beginning October 1, 2015, the minimum hourly wage for city-employees shall be \$9.70.
- b. Beginning October 1, 2016, the minimum hourly wage-for-city-employees-shall be \$10.65.
- (3) Each city employee shall certify to the city personnel department that the employee will be compensated at a rate of pay not less than the minimum hourly wage in effect, as set forth by this section.
- SECTION 2. Should any sentence, paragraph, subdivision, clause, phrase, or section of this Article be adjudged or held to be unconstitutional, illegal, or invalid, the same shall not affect the validity of this Article as a whole, or any part or provision thereof other than the part so decided to be invalid, illegal, or unconstitutional, and shall not affect the validity of the Code of Ordinances of the City of Jackson, Mississippi, as a whole.
- **SECTION 3.** This ordinance shall become effective thirty (30) days after passage, and upon publication in accordance with Section 21-13-11 of the Mississippi Code Annotated (1972), as amended.

## RESOLUTION OF THE CITY OF JACKSON SUPPORTING EXPANDING THE UNIVERSITY OF MISSISSIPPI MEDICAL CENTER AND DEMOLISHING VETERAN'S MEMORIAL STADIUM. (STAMPS)

WHEREAS, The University of Mississippi Medical Center (UMMC), is the state's only academic health sciences center.

WHEREAS, UMMC works to improve the life of Mississippians by providing exceptional patient care, training the next generation of health care providers, and engaging in innovative research.

WHEREAS, a recent community health needs assessment conducted by UMMC showed the leading health issues in Mississippi to be: Access to Healthy Food, Type 2 Diabetes, Obesity, Cardiovascular Disease, lack of Health Insurance, Mental Health, Education, and Health Disparities. This report also reported strong dissatisfaction with the quality and access of healthcare in their communities, with several focus group participants communicating a strong distrust of healthcare providers in their communities.

WHEREAS, the recent Coronavirus pandemic has exposed the need for increased capacity in Mississippi's hospital system. As intensive-care units filled up with coronavirus patients during the early summer, Mississippi, state health officials were at one time considering opening pop-up facilities to provide more beds for coronavirus patients.

WHEREAS, plans are already in place for a new Ambulatory Clinic Facility and a new Cancer Institute building, but more Intensive Care Unit (ICU) beds and regular treatment beds are needed to make sure we are prepared for any future health crisis on the scale of the Corona Virus pandemic.

**NOW, THEREFORE BE IT RESOLVED** that the City of Jackson fully supports expanding the University of Mississippi Medical Center and demolishing Veteran's Memorial Stadium to create room to expand.

ORDER AUTHORIZING THE MAYOR TO EXECUTE AN INTERLOCAL COOPERATIVE AGREEMENT BETWEEN THE CITY OF JACKSON, MISSISSIPPI, AND HINDS COUNTY, MISSISSIPPI, TO PROVIDE FIVE HUNDRED THOUSAND DOLLARS (\$500,000.00) TO HINDS COUNTY, MISSISSIPPI, TO ENGAGE DEPUTIES OF THE SHERIFF OF HINDS COUNTY TO ASSIST WITH PUBLIC SAFETY ACTIVITIES WITHIN THE CITY OF JACKSON, MISSISSIPPI.

WHEREAS, during the City Council meeting on October 13, 2020, the City of Jackson, by resolution (Item #65), declared a crisis of violence within the City of Jackson; and

WHEREAS, by way of the afore-mentioned resolution (Item #65) and another resolution, Item #66, passed during that same meeting, the City recognizes the fact that the Jackson Police Department (JPD)is presently understaffed and in need of tangible assistance; and

WHEREAS, pursuant to the afore-mentioned resolutions passed on October 13, 2020, and in consideration of the public health, safety and welfare of the citizens of the City of Jackson, the City should enter into an interlocal cooperative agreement with Hinds County, Mississippi to engage Deputies of the Sheriff of Hinds County, Mississippi to assist with public safety activities within the City of Jackson, Mississippi.; and

WHEREAS, under the proposed interlocal agreement the City of Jackson would provide \$500,000 to Hinds County to hire additional deputies to assist with public safety within the City of Jackson, Mississippi; and

WHEREAS, the proposed interlocal cooperative agreement would continue from the effective date as until such time as the crisis has been abated, the funds have been expended, and activities contemplated by the interlocal agreement have been completed.

THEREFORE, IT IS HEREBY ORDERED that pursuant to the Interlocal Cooperation Act of 1974 and other applicable law, the Mayor is authorized to execute an interlocal agreement between the City of Jackson, Mississippi and the Hinds County to provide \$500,000 to Hinds County to hire additional deputies to assist with public safety within the City of Jackson, Mississippi.
