During Executive Session, the Council took action on Agenda Item No. 2:

ORDER OF THE CITY COUNCIL OF JACKSON, MISSISSIPPI AUTHORIZING THE MAYOR TO EXECUTE A CONTRACT AND RELATED DOCUMENTS TO PROVIDE SOLID WASTE COLLECTION AND HAULING SERVICES FOR A SIX (6) YEAR TERM COMMENCING OCTOBER 1, 2021 WITH FOUR (4) ONE (1) YEAR MUTUAL EXTENSION OPTIONS PURSUANT TO THE CURRENT RFP PROCESS FOR SOLID WASTE COLLECTION AND VALID MISSISSIPPI LAW BEFORE SEPTEMBER 30, 2021, PRIOR TO EXPIRATION OF THE CURRENT SOLID WASTE COLLECTION CONTRACT.

WHEREAS, the City Council of Jackson Mississippi, firmly believes in its responsibility to protect the financial position of the city from lawsuits and/or fines, regarding non-compliance with state procurement and request for proposal (RFP) laws that govern municipalities in the State of Mississippi; and

WHEREAS, the City Council of Jackson, Mississippi, believes that it is the intent of the administration to allow an interruption in solid waste collection services for the purpose of declaring an emergency to abate the State of Mississippi's procurement and RFP law process that governs municipalities; and

WHEREAS, due to the extreme nature of intentionally causing an interruption in services, the city council invokes its right as the governing authority of this city "to pass an ordinance, resolution or order providing that the municipality will enter into a contract for a specific purpose, the mayor must take appropriate action to comply with such an action…" MS AG Op. Lawrence (October 12, 2007); and

WHEREAS, the City Council of Jackson, Mississippi, the governing authority and legislative body of the City of Jackson, firmly believes that failure to negotiate with one or more of the proposers according to the terms of the RFP, forces the governing authority to forgo its responsibility to uphold state law and protect the city of Jackson from an environmental emergency. Thereby, placing the City of Jackson at risk of facing fines in accordance to Miss. Code 17 -17-29; and

WHEREAS, the City Council of Jackson has determined that it is in the best interest of the city to authorize the mayor to execute a contract with one or more of the request for proposal (RFP) respondents to provide the required service of collection of garbage; and

WHEREAS, in the case of Home Base Litter Control, LLC, Appellant v. Claiborne County, Mississippi, Appellee, of June 16, 2015, the court of Appeals, Roberts, J. held that 2. County could not be estopped from taking position contrary to request for proposal (RFP); and

WHEREAS, the City Council of Jackson Mississippi realizes the importance of identifying a vendor to provide solid waste collection services before October 1, 2021 and understands that not doing so threatens the health, safety, and well-being of the citizens of Jackson.

BE IT HEREBY RESOLVED that the City Council of Jackson Mississippi hereby authorizes the Mayor to execute a contract and related documents to provide solid waste collection and hauling services for a six (6) year term commencing October 1, 2021 with four (4) one (1) year mutual extension options pursuant to the current RFP process for solid waste collection and valid Mississippi law before September 30, 2021.
