ORDER AMENDING THE FEBRUARY 1, 2022 APPROVED ORDER AUTHORIZING THE MAYOR TO EXECUTE A MASTER SERVICE AGREEMENT WITH PILEUM CORPORATION TO REFLECT THE PROPER ENTITIES PILEUM CORPORATION AND METRIX SOLUTIONS AS COMBINED PROVIDER(S) OF PALO ALTO NETWORK FIREWALL APPLIANCE AND AUTHORIZING AND RATIFYING PAYMENT TO PILUEM CORPORATION FOR SERVICES RENDERED.

WHEREAS, pursuant to Miss. Code Ann. § 31-7-59(1), "any municipality over one hundred thousand population is empowered to purchase from the General Services Administration, without advertising for bids, any and all articles of supplies and equipment necessary for the operation of said municipality so long as the purchase price of such articles is below the purchase price of similar articles on a state contract accepted by the Office of General Services"; and

WHEREAS, after performance delays, the Department of Administration obtained firewall and the City of Jackson was granted an evaluation period which allowed demo units of the firewall to be installed to protect and stabilize the City's network; and

WHEREAS, this firewall allows content scanning to protect the City of Jackson against viruses, spyware, data leakage, and application vulnerabilities; and

WHEREAS, the initial evaluation period was set to expire August 2021, however, the City was granted monthly extensions to date; and

WHEREAS, the evaluation period for the installed demo units has expired; and

WHEREAS, by Order entered on February 1, 2022, the governing authorities authorized the Mayor to execute an agreement with Pileum Corporation to provide both the physical appliance and software application to secure the network by identifying, controlling, and inspecting our SSL encrypted traffic and applications in realtime; and

WHEREAS, after the said Order was entered, the Department of Administration determined that the proper and correct names; and

WHEREAS, Pileum Corporation provides both the implementation of software along with hardware support and consulting services for the firewall appliance currently located at 353 S. Congress St after executed agreement; and

WHEREAS, Metrix Solutions, the product reseller, provides the software application and hardware appliances as to secure the network by identifying, controlling, and inspecting our SSL encrypted traffic and applications in real-time; and

WHEREAS, the cost of procurement is \$314,174.59 beginning upon execution through February 28, 2025 on a three (3) year agreement; and

WHEREAS, the products listed in the master service agreement reflect GSA prices for the firewall equipment; and

WHEREAS, the Department of Administration recommends the firewall as the City's maintenance needs for support and software upgrades are substantial and execution of the master service agreement is recommended.

WHEREAS, in order to ensure the continued safety of children, teachers, and staff, the Department of Human and Cultural Services is requesting that the procurement of services be ratified and authorized for payment; and

IT IS, THEREFORE, ORDERED that the Mayor is hereby authorized to execute-an addendum to the master service agreement with Pileum Corporation for the City of Jackson's to reflect the proper entities Pileum Corporation and Metrix Solutions as combined provider(s) of the Palo Alto Network firewall appliance; authorizing and ratifying payment to Pileum Corporation for the services rendered; and that the Mayor may is authorized to execute any other documents necessary for the Palo Alto Network firewall infrastructure.

ORDER AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT BETWEEN THE CITY OF JACKSON, MISSISSIPPI; HINDS COUNTY CIRCUIT CLERK, AND HIND COUNTY, MISSISSIPPI, RELATED TO THE APRIL 5, 2022

MINUTE BOOK 6U

WHEREAS, pursuant to Section 21-33-553(3) of the Mississippi Code of 1972, as amended, the City of Jackson, Mississippi ("City of Jackson"), shall conduct a special election to create a special local improvement assessment district for Belhaven and Belhaven Heights; and

WHEREAS, the Jackson City Council has approved a Special Election for Belhaven and Belhaven Heights on April 5, 2022; and

WHEREAS, Hinds County, Mississippi owns the necessary voting equipment to conduct the Special Election properly; and

WHEREAS, the Hinds County City Clerk and the Municipal Election Commissioner for Ward 7 determined that the use of County voting machines is necessary to conduct said election properly and that the services of the Hinds County Circuit Clerk are needed to create the Special Election in the Statewide Election Management System (SEMS); and

WHEREAS, the proposed agreement contains the following provisions:

- Hinds County, Mississippi ("Hinds County"), by and through the Hinds County Circuit Clerk will make available to the City of Jackson the following equipment: 2-DS 200 Scanners and 3-Express Vote with tables and keys.
- The City of Jackson assumes all responsibility for destruction, negligence, or any other damage to County equipment and agrees to indemnify, hold harmless and otherwise fully compensate at the County for any claims and losses, to the extent allowable by Mississippi Law.
- Upon completion of the usage of said equipment, the City of Jackson agrees to remit to Hinds County the amount of Two Hundred Fifty Dollars and No Cents (\$250.00) for usage of equipment provided during the April 5, 2022 Special Election. Payment will be made payable to the Hinds County Chancery Clerk.

IT IS, THEREFORE, ORDERED that the Mayor is hereby authorized to execute an agreement with the Hinds County, Mississippi for the use of voting equipment and services related to the creation of the election in the SEMS, in an amount not to exceed Two Hundred Fifty Dollars and No Cents (\$250.00) for the Special Election.

ORDER RATIFYING THE ACCEPTANCE OF FOOD SERVICES FROM BLOUNT ENTERPRISES, D/B/A COUNTRY FISHERMAN FOR SERVICES RENDERED TO THE JACKSON POLICE TRAINING ACADEMY FROM DECEMBER 13, 2021 TO MARCH 22, 2022 AND ALSO AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT BETWEEN THE JACKSON POLICE DEPARTMENT AND BLOUNT ENTERPRISES D/B/A COUNTRY FISHERMAN FOR FOOD SERVICES AT THE JACKSON POLICE TRAINING ACADEMY BEGINNING MARCH 23, 2022 AND ENDING DECEMBER 31, 2022.

WHEREAS, the City of Jackson Police Department ("JPD") is conducting 8-week bubble recruit classes to train and certify new police officers, and

WHEREAS, the Police Recruits are housed in the barracks of the City of Jackson Police Training Academy for the duration of their training, and

WHEREAS, the Jackson City Council on September 28, 2021 previously authorized the JPD to utilize services of the Country Fisherman to provide meals during the 65th recruit class, and

WHEREAS, JPD budgeted for this expenditure in its FY 22 General Fund budget, but was unsuccessful in receiving responses for its term bid, but intends to place another Request For Proposal ("RFP") in September 2022 for these services, and

WHEREAS, Blount Enterprises, d/b/a Country Fisherman also provided meals for 100 persons at the graduation of the first Clergy Police Academy at the City of Jackson Police Training Academy on December 13, 2021 at a cost of four hundred seventy-seven dollars and ninety-two cents (\$477.92), and

WHEREAS, the JPD began its 66th recruit class on December 19, 2021 without a food services contract in place, and

WHEREAS, Blount Enterprises, d/b/a Country Fisherman agreed to continue to serve lunch and dinner meals for 66th recruit class at a cost of \$9.50 per person per meal Monday through Thursday and \$10.00 per person per meal Friday through Sunday, and

WHEREAS, to date, the cost of services rendered to the JPD by Blount Enterprises, d/b/a Country Fisherman totals an amount not to exceed twelve thousand three hundred eighty-seven dollars and ninety-two (\$12,387.92), and

WHEREAS, Blount Enterprises, d/b/a Country Fisherman is willing to continue to provide meals at a cost of \$9.50 per person per meal Monday through Thursday and \$10 per person per meal Friday through Sunday from March 23, 20202 to December 31, 2022 at an amount to exceed twenty-six thousand dollars (\$26,000.00), and

WHEREAS, it has been generally held through Mississippi Case Law and Attorney General Opinions that governing authorities are not "required", but "recommended" to follow competitive bid requirements in the procurement of personal or professional service contracts and pursuant to Miss. Code. Ann.§ 31-7-57(2), no governing authority shall let contracts or purchase commodities or equipment except in the manner provided by law; nor shall any governing authority ratify any such contract or purchase... or pay for the same out of public funds unless such contract or purchase was made in the manner provided by law; provided however, that any vendor who, in good faith, delivers commodities or printing or performs any services under a contract to or for the governing authority, shall be entitled to recover the fair market value of such commodities, printing or services, notwithstanding some error or failure by the governing authority to follow the law, if the contract was for an object authorized by law and the vendor had no control of, participation in, or actual knowledge of the error or failure by the governing authority; and

WHEREAS, the ratification, extension and/or reinstitution of this agreement will give JPD sufficient time to do the RFP in September 2022 for these services.

IT IS FURTHER ORDERED that the food services received from Blount Enterprises, d/b/a Country Fisherman on December 13, 2021 in the amount of four hundred seventy-seven dollars and ninety-two cents (\$477.92) be paid from account 001- 442.26.6419.

ORDER AUTHORIZING THE MAYOR TO EXECUTE CONTRACT BETWEEN THE CITY OF JACKSON AND GRACE HOUSE, INC. FOR THE USE OF 2021 HOUSING OPPORTUNITIES FOR PERSONS WITH AIDS (HOPWA) PROGRAM FUNDS IN THE JACKSON METROPOLITAN STATISTICAL AREA(MSA) FOR A TOTAL OF \$1,385,902.00 FROM THE DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD).

WHEREAS, on May 13, 2021 HUD notified the City of Jackson of its 2021 allocations for the Office of Community Planning and Development's (CPD) formula programs, which provide funding for housing, community and economic development activities, and assistance for low-and moderate-income persons and special needs populations across the country; and

WHEREAS, by Order entered on August 3, 2021, recorded in Minute Book 6T, Page 378, the governing authorities authorized the Mayor to submit to the U.S. Department of Housing and Urban Development The City Of Jackson's 2021 One-Year Annual Action Plan Of the 2020-2024 Consolidated Plan in the amount of \$4,282,141.00; and

WHEREAS, the Office of Housing and Community Development recommends entering into a contract with Grace House, Inc. to provide eligible HOPWA services to residents of the City of Jackson's Metropolitan Statistical Area, which includes Hinds, Rankin, Madison, Copiah, Holmes, and Simpson counties; and

WHEREAS, the contracts shall be effective February 1, 2022 – June 30, 2023 in the amount of \$1,385,902.

IT IS, THEREFORE, ORDERED that the Mayor be authorized to execute contracts with Grace House, Inc. for the implementation of the Housing Opportunities for Persons With AIDS (HOPWA) program in the Jackson Metropolitan Statistical Area (MSA) for the use of 2021 HOPWA funds; and to execute all other required forms and contractual documents related to this award.

ORDER ACCEPTING THE BID OF GCW PAVEMENT SERVICES, LLC FOR BUS STOP IMPROVEMENT PROJECT AND AUTHORIZE THE MAYOR TO EXECUTE A CONTRACT AND RELATED DOCUMENTS OF THE CITY OF JACKSON'S PUBLIC TRANSPORTATION SYSTEM.

WHEREAS, the City of Jackson ("City") has determined that it is in the City's best interest to seek a construction company for the bus stop improvement project of the City's public transit system; and

WHEREAS, the Department of Planning and Development, through its Transit Division, issued a Request for Proposals on December 1, 2021, for a qualified firm for the bus stop improvement project; and

WHEREAS, in response to the Request for Proposal, the Transit Division received responses from two (2) companies qualified to provide said construction; and

WHEREAS, the bid of GCW Pavement Services, LLC, in the amount of four hundred seventy-two thousand fifty-three dollars and one cent (\$472,053.01) was the lowest bid received; and

WHEREAS, GCW Pavement Services, LLC, will achieve bus stop improvement project of the City's public transportation system by providing Mobilization, Removal of Obstructions (all sizes existing shelters, benches, and abandoned power poles), Removal of Concrete (Full Depth), Removal of Curb and Gutters (all types), Excess Excavation (FM/AHO, Temporary Silt Fence, 12 " Wattles, Sawcutting of Concrete Surfaces, Concrete Sidewalk & Shelter pad, Concrete Curb & Gutters, Maintenance of Traffic, 8-FT/16-FT Bus Stop Shelters, Benches, and Solar Packages; and

WHEREAS, Time is of the Essence, work will be substantially completed within one hundred twenty (120) after Contract Commencement Date; and

WHEREAS, Bus Stop Improvement Project of the City's Public Transportation System shall be completed and ready for final payment within one hundred fifty days (150) after contract commences; and

WHEREAS, GCW Pavement Services, LLC, shall payliquidated damages per calendar day at a rate of five hundred dollars and zero cent (\$500.00) for Substantial Completion, two hundred fifty dollars and zero cent (\$250.00) for Contract Completion per calendar day until work is complete; and

WHEREAS, the Transit Division is recommending that the governing authorities authorize the Mayor to execute a Contract and related documents with GCW Pavement Services, LLC for construction of the bus stop improvement project of the City's public transportation system at a cost not to exceed four hundred seventy-two thousand fifty-three dollars and one cent (\$472,053.01); and

WHEREAS, the Federal Transit Administration will pay eighty percent (80%) of the cost or three hundred seventy-seven thousand six hundred forty-two dollars and forty-one cent (\$377,642.41), with a twenty percent (20%) local match or ninety-four thousand four hundred ten dollars and sixty cents (\$94,410.60).

IT IS, THEREFORE, ORDERED that the Mayor is authorized to execute a Contract and related documents with GCW Pavement Services, LLC for construction of the bus stop improvement project at a cost not to exceed four hundred seventy-two thousand fifty-three dollars and one cent (\$472,053.01), with eighty percent (80%) of the cost or three hundred seventy-seven thousand six hundred forty-two dollars and forty-one cent (\$377,642.41) to be paid by the Federal Transit Administration and twenty percent (20%) or ninety-four thousand four hundred ten dollars and sixty cent (\$94,410.60) from local match.
