WHEREAS, the City Council of Jackson, Mississippi has determined that a conflict does exist between the City Attorney's Office and the City of Jackson; and

WHEREAS, the City Council of Jackson, Mississippi has determined that it is in the best interest of the City of Jackson to defend this lawsuit by retaining the independent legal counsel of **Begley Law Firm**; and

IT IS, THEREFORE, ORDERED that the firm of <u>Begley Law Firm</u> is retained as the independent legal counsel of the City of Jackson at an hourly rate between <u>\$250.00</u> and <u>\$250.00</u> per hour based upon the skill and experience of the assigned counsel for the charged task for the purpose of defending the City of Jackson in the lawsuit styled "Chokwe A. Lumumba, in his official capacity as Mayor of the City of Jackson vs The City Council of Jackson, Mississippi".

BE IT FURTHER ORDERED that the attorney's fees and other expenses of litigation, including but not limited to expert witness fees, court reporter fees, copying, faxes, and long-distance telephone calls shall not exceed <u>\$250.00 per hour</u> further approval of the City Council of Jackson, Mississippi.
