**ORDER AUTHORIZING 2013 GENERAL OBLIGATION BOND PAYMENT TO US BANK IN THE AMOUNT OF \$985,000.00.**

**WHEREAS**, on February 14, 2023, the City Council of Jackson, Mississippi approved payment to US Bank in the amount of \$108,843.75 for interest on the 2013 General Obligation Bond; and

**WHEREAS**, the amount was incorrect and should be \$1,094,843.75.

**IT IS, THEREFORE, ORDERED** that a payment in the amount of \$985,000.00 should be made payable to the US Bank on March 1, 2023 to satisfy bond repayment requirements.
