To be specific: We request a record or records of two Jackson City Council actions on 12/17/1990. The first action was approving (to quote the Hinds County document) "the proposed agreement between Mobile Medic Ambulance Service, Inc. and Hinds County, Mississippi styled, 'Agreement to provide advanced support ambulance service.'" The second 12/17/1990 Council action for which we are requesting a record is described in the same paragraph in the same County document. Here, we refer to the language, "and directed the execution of that certain agreement styled, 'Agreement between Hinds County and the City of Jackson for the provision of ambulance service.'" We do not know if the City Council passed one or two motions to effect the two actions above. We wish to obtain a record or records of the Council's action or actions on both matters described above.
