I had a plumber service the house twice and finally decided to replace the main line that runs from my house to the city connection under the road. The plumber discovered there was a collapsed line approximately 7' out in the road and suggested having the city come to inspect. In the meantime, the plumber created a cleanout valve so that waste could clear out into the yard to prevent it from coming into the home. I reached out to the city at that time and was never contacted with details. The weekend of November 11th, the water began coming into the house. I had the same plumber come to flush the mainline to relieve pressure on the house. He found that the newly replaced mainline is completely clogged because there is nowhere for it to be released since it is not connected due to the collapsed line. I spoke with the sewer department on November 15th and was told a technician ran a camera to detect the collapsed line was my responsibility to fix.
