## ORDINANCE NO. 2017-9-26C

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF JARRELL, TEXAS, DECLARING THE UNOPPOSED CANDIDATES FOR THE OFFICES OF ALDERMAN PLACE 3, ALDERMAN PLACE 4 AND ALDERMAN PLACE 5 AS ELECTED; PROVIDING THAT THE NOVEMBER 7, 2017, GENERAL MUNICIPAL ELECTION SHALL NOT BE HELD; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH; PROVIDING A SAVINGS CLAUSE; PROVIDING A SEVERABILITY CLAUSE; OPEN MEETING CLAUSE AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City Council of the City of JARRELL, Texas, adopted Ordinance No. 2017-8-8 on August 8, 2017, ordering a general municipal election to be held on November 7, 2017, for the purpose of electing three officials of the City, to wit: Alderman Place 3, Alderman Place 4 and Alderman Place 5; and

**WHEREAS**, pursuant to Section 143.007 and 146.054, Texas Election Code, the deadline for filing applications for a place on the ballot and declaration of write-in candidacy for the City's regular municipal elections have expired; and

**WHEREAS**, the City Secretary, in accordance with Section 2.052, Texas Election Code, has certified in writing to the City Council that Troy Bradshaw is unopposed for election to the office of Alderman Place 3, Rusty Bryson is unopposed for election to the office of Alderman Place 4 and Ruth Dotson is unopposed for election to the office of Alderman Place 5; and

**WHEREAS**, the City Council hereby finds and determines that the candidates whose names are to appear on the ballot in said election are unopposed, there are no declared write-in candidates; and

**WHEREAS**, the Order of Cancellation is attached as **Exhibit "A"** for posting purposes in English and Spanish for all voting locations.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF JARRELL, THAT:**

**Section 1.** The facts and matters set forth in the preamble of this Ordinance are hereby found to be true and correct.

**Section 2.** In accordance with Section 2.053(a), Texas Election Code, the following unopposed candidates are hereby declared duly elected to the respective offices shown and shall be issued a certificate of election following the date on which the regular municipal election for Alderman Place 3, Alderman Place 4 and Alderman Place 5 was to have been held:

**Alderman Place 3 – Troy Bradshaw**  
**Alderman Place 4 – Rusty Bryson**  
**Alderman Place 5– Ruth Dotson**

**Section 3.** Pursuant to Section 2.053(b), Texas Election Code, the regular municipal election for Alderman 3, Alderman Place 4 and Alderman Place 5 called and ordered by Ordinance No. 2017-8-8, for November 7, 2017, shall not be held and is hereby canceled.

**Section 4.** The City Secretary is hereby directed to cause a copy of **Exhibit "A"** Order of Cancellation to be posted on Election Day, same being November 7, 2017, at all voting locations that would be used in such election.


**Section 5.** All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to be extent of such conflict.

**Section 6.** Should any section, paragraph, sentence, clause, phrase or word of this ordinance be declared unconstitutional or invalid for any purpose by a court of competent jurisdiction, the remainder of this ordinance shall not be affected thereby, and to this end the provisions of this ordinance are declared to be severable.

**Section 7.** It is hereby found and determined that the meeting at which this ordinance was passed was open to the public as required by Section 551.001, Texas Government Code, and that advance public notice of the time, place and purpose of said meeting was given.

**PASSED AND APPROVED** this 26<sup>th</sup> day of September 2017, by a vote of 5 Ayes and 0 Nays at a regular meeting of the City Council of the City of JARRELL, Texas.



Alderman Place 5	Ruth Doston






