ORDINANCE NO. 2019-0924-03

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF JARRELL, TEXAS, DECLARING THE UNOPPOSED CANDIDATE FOR THE OFFICE FOR THE UNEXPIRED ONE YEAR TERM OF ALDERMAN PLACE 1, AS ELECTED; PROVIDING THAT THE NOVEMBER 5, 2019, SPECIAL ELECTION SHALL NOT BE HELD; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH; PROVIDING A SAVINGS CLAUSE; PROVIDING A SEVERABILITY CLAUSE; OPEN MEETING CLAUSE AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Jarrell, Texas, adopted Ordinance No. 2019-0723-02 on July 23, 2019, ordering a Special Election to be held on November 5, 2019, for the purpose of electing Alderman Place 1 for the one-year unexpired term for such City;

WHEREAS, pursuant to Section 143.007 and 146.054, Texas Election Code, the deadline for filing applications for a place on the ballot and declaration of write-in candidacy for the City's Special Election has expired; and

WHEREAS, the City Secretary, in accordance with Section 2.052, Texas Election Code, has certified in writing to the City Council that Daniel Klepac is unopposed for election to the office, of Alderman Place 1 for the one-year unexpired term for such City; and

WHEREAS, the City Council hereby finds and determines that the candidate whose name is to appear on the ballot in said election is unopposed, there are no declared write-in candidates; and

WHEREAS, the Certification of Unopposed Candidates for The City of Jarrell 2019 Special Election is attached as **Exhibit "A"** for posting purposes in English and Spanish for all voting locations.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF JARRELL, THAT:

Section 1. The facts and matters set forth in the preamble of this Ordinance are hereby found to be true and correct.

Section 2. In accordance with Section 2.053(a), Texas Election Code, the following unopposed candidate is hereby declared duly elected to the respective office shown and shall be issued a certificate of election following the date on which the Special Election for Alderman Place 1 for the one-year unexpired term for such City; was to have been held:

Alderman Place 1 – Daniel Klepac

Section 3. Pursuant to Section 2.053(b), Texas Election Code, the Special Election for the one-year unexpired term Alderman Place 1 for such City; called and ordered by Ordinance No. 2019-0723-02 on July 23, 2019, shall not be held and is hereby canceled.

Section 4. The City Secretary is hereby directed to cause a copy of **Exhibit "A"** Certification of Unopposed Candidates for The City of Jarrell 2019 Special Election to be posted on Election Day, same being November 5, 2019, at all local voting locations that would be used in such election.

Section 5. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to be extent of such conflict.

Section 6. Should any section, paragraph, sentence, clause, phrase or word of this ordinance be declared unconstitutional or invalid for any purpose by a court of competent jurisdiction, the remainder of this ordinance shall not be affected thereby, and to this end the provisions of this ordinance are declared to be severable.

Section 7. It is hereby found and determined that the meeting at which this ordinance was passed was open to the public as required by Section 551.001, Texas Government Code, and that advance public notice of the time, place and purpose of said meeting was given.

PASSED AND APPROVED this 24th day of September, 2019, by a vote of 3 Ayes and 0 Nays at a regular meeting of the City Council of the City of Jarrell, Texas.
