3.1 Opened a Public Hearing to consider the request of Bleyl Engineering on behalf of Amirali Maknojia (optionee) to change the zoning of a tract located at 9500 IH35, Jarrell, Texas 76537 from C2 to Il.

3.2 Consideration and possible recommendation to the City Council regarding the request of Bleyl Engineering on behalf of Amirali Maknojia (optionee) to change the zoning of a tract located at 9500 IH35, Jarrell, Texas 76537 from C2 to I1.
