

Summary of Request:

With this proposed amendment, the by-laws would be updated.



Section 1.06.061 Appointment of Members. The membership of the City of Jarrell's Planning and Zoning Commission shall be composed of five (5) members who are appointed by the City Council for terms of two (2) years. The Commission members shall be comprised of at least three (3) members that reside within the city limits of Jarrell and shall be registered voters and have resided within city limits for at least six (6) months preceding their appointment. The remaining two (2) members may reside within the Extraterritorial Jurisdiction (ETJ) of the city for at least six (6) months preceding their appointment. In the absence of qualified candidates, the City Council may waive these requirements to fill a vacant post. A majority of the appointed members shall constitute a quorum for the transaction of business.

- A. The Mayor and the Council are responsible for appointing the members of the Commission.
- B. Members shall be appointed by a vote of majority of the Council in open meeting unless otherwise provided by law.
- C. Members shall serve without compensation for their services.
- D. Commission members may be removed from office for any reason.

Section 1.06.062 Terms. The terms of each of the members is two (2) years and is staggered, except that the respective terms of three (3) members of the Commission appointed is one year initially and two years thereafter. Terms end September 30th of each year. All vacancies shall be filled for the unexpired term by the Council in the same manner as provided for in the original appointments. A Commission member may be removed from office for any reason.

Section 1.06.063 Alternate Commission Members. The City Council is authorized to appoint one (1) or more alternate members of the Commission who shall serve in the absence of the one (1) or more regular members of the Commission who shall serve in the absence of the one (1) or more regular members when requested to do so by the Chairperson of the Commission. Alternate members serve for the same term and are subject to removal in the same manner as regular members. A vacancy is filled in the same manner as a vacancy among the regular members.

Section 1.06.064 Meetings.

- A. All members of the Commission shall endeavor to attend all meetings. Any member of the Commission failing to attend three (3) consecutive scheduled meetings without good cause shall be subject to removal from the Commission by the Council. All members who will miss a meeting, whether scheduled or called, shall endeavor to give prior notification to the Chairman and/or Vice-Chairman as soon as possible.
- B. Any member of the Commission who has or believes that she/he has a conflict of interest in a matter that is to be considered and/or acted upon by the Commission shall excuse herself/himself from the consideration and/or action and refrain from discussing and/or voting on said item in her/his official capacity as a Commission Member.

- C. All meetings of the Commission shall be governed by the Texas Open Meetings Act, Tex. Gov't Code, Chapter 551.
- D. Meetings of the Commission shall be held in the City of Jarrell Council Chambers at 5:30 p.m. on the second (2nd) Tuesday of each month, unless otherwise posted. Special meetings may be called as necessary with notice to the Council and to the public. Special meetings may be called by the Mayor, the City Manager, the Chairman of the Planning and Zoning Commission. All meetings shall be open to the public, unless an executive session is conducted. Public notice of all meetings shall be posted in accordance with State Law.
- E. A majority of three (3) of the five (5) members shall constitute a quorum for holding a meeting and for taking any action. No action shall be taken on any item before the Commission in the absence of a quorum.
- F. The Chairman will initiate motions and may also vote on each issue. Voting shall be by hand or may be made verbally and noted by the Secretary. The affirmative vote of a majority of members constituting a quorum of the Commission shall be necessary and sufficient for any recommendation, resolution, plan, or other voting matter.
- G. An agenda listing the items and in the order in which they are to be considered shall be posted seventy-two (72) hours before each meeting. Anyone wishing to have an item placed on the agenda must contact staff one week prior to the posting of the agenda.

Section 1.06.065 Responsible to Council. The Commission is responsible to and shall act as an advisory body to the Council and shall perform such duties and exercise such additional powers as may be described by ordinances of the City.


Section 1.06.066 Organization. The Commission is responsible for selecting a Chairman, Vice-Chairman, and Secretary, and such other officials as deems necessary from its membership. The Chairman shall act as a liaison between the City Council and the Planning and Zoning Commission and will lead all Planning and Zoning Commission meetings. The Vice-Chairman shall perform the duties of the Chairman in his/her absence. The City Secretary will post agendas of meetings in accordance with City ordinances and state laws. The City Secretary shall record minutes of all meetings. In the City Secretary's absence, the Secretary of the Commission shall record the minutes and submit an original copy within three (3) days after the meetings to the City Secretary. Selection of officers shall be conducted every October or at the next scheduled meeting thereafter.

Section 1.06.067 Powers and Duties. The Commission must always bear in mind that the issues before it are never primarily for the profit or loss to a particular individual or entity, but the maintenance of such system of planning and zoning that will best serve the interests of the city community as a whole.

The Commission has the power, and it shall be its duty:

A. To make appropriate surveys, investigations, reports, and recommendations relating to community planning and development to the Council, and to recommend the approval,

- disapproval, modification, or rejection of all plans, plats or re-plats of land, additions, subdivisions, and properties with the City;
- B. To make plans or maps of whole and part of the City and of land outside the City located with five miles of the City limits and any other land outside the City, which, in the opinion of the Commission, bears a relation to the planning of the City and to make changes, in additions to, and extensions of such plans or maps when it deems the same advisable;
- C. To act with and assist all other municipal and government agencies, and particularly the Council, in formulating and executing proper plans or maps for municipal development and growth;
- D. To recommend to Council the passage of such ordinances as it may deem necessary to carry out its program;
- E. To recommend to the Council approval or disapproval of proposed changes in the City's Zoning Ordinance and plans, and to make any recommendations concerning any future zoning plans;
- F. To make and adopt a comprehensive community plan for the guidance and control of the future development of the community. A review and recommendation to council shall be annually:
- G. To aid and assist the Council in the annual preparation of long-range capital improvement budget, and determination of sources of funds therefore;
- H. To investigate and evaluate the opening, vacating, narrowing, abandoning, or changing the scope, character and standards for streets, roads, and alleyways within the City's extraterritorial jurisdiction;
- 1. Perform such other duties as may be prescribed by ordinance or state law;
