### A RESOLUTION CANVASSING AND DECLARING THE RESULTS OF THE CITY OF JARRELL NOVEMBER 8, 2022 GENERAL ELECTION

**WHEREAS,** The City of Jarrell, Texas conducted a General Election, held on November 8, 2022, for the purposes of electing City Council members for the Mayor, Alderman Place 1 and Alderman Place 2; and

**WHEREAS,** the November 8, 2022 General Election was duly and legally held in conformity with the election laws of the State of Texas and was conducted by the Williamson County Elections Department on behalf of the City of Jarrell, Texas; and

**WHEREAS, WHEREAS,** the November 8, 2022 Notice of General Election with Early Voting and Election Day Voting locations, dates and times were properly posted in accordance with Texas Election Code § Title 1: Introductory Provisions: Chapter 3: Ordering Election and Chapter 4: Notice of Election and Local Government Code § Title 5: Open Government: Section 551: Open Meetings; and

**WHEREAS,** The City of Jarrell, Texas is a Type A-General Law City and officials are elected by the plurality vote pursuant to the Texas Election Code § 2.001.
