- Discussion and possible action regarding the Jarrell EDC FY 23-24 Budget. 7.1. Barry Cryer made a motion to approve the Jarrell EDC FY 23-24 Budget with an amendment to the Auto Expense to reflect an increase to \$12,000. Second by Thomas Hertel. The motion was approved by a unanimous vote.
- Discussion and possible action regarding adopting an Incentive Policy and Application. 7.2. Executive Director Anderson showed the Board what documents were found regarding Incentive Application and Due Diligence. These will be re-worked and brought back to the Board.





- 7.3. Discussion and possible action regarding adopting a Social Media Policy.

 Executive Director Anderson provided the Board with a Social Media Policy, but explained this was just put together and not vetted by the attorney yet. Dr. Hicks mentioned checking with JISD on what their policy was as well.

Executive Director Anderson is proposing a \$10,000 budget amendment to cover the cost of a recruitment trip with Wilco EDP. The Board discussed the trip and costs and would like to increase the amount of the amendment to \$20,000.

Thomas Hertel made a motion to reallocate fund in an amount of \$20,000 from the HEDC FY 22-23 budget line item "Projects" to line item "Travel/Training". Second by Barry Cryer. The motion was approved by a unanimous vote.
