The appointment of Brent Sultemeier as the Public Works Director was tabled until the September 15<sup>th</sup> special meeting.


**8. DISCUSSION AND ACTION REGARDING AMENDMENT TO DISASTER DECLARATION FOR REOPENING OF CITY HALL.**
