- 5. DISCUSSION AND ACTION REGARDING THE APPOINTMENT OF THE FOLLOWING MEMBERS TO THE PLANNING & ZONING COMMISSION TO A TWO (2) YEAR TERM ENDING AUGUST 2022:

Council member Dildine made a motion to reappoint Suree Birck, Kevin Tully, and Victor Hammond to the Planning and Zoning Commission with the term expiring August of 2022. Council member Young seconded the motion. All were in favor and the motion passed.

6. DISCUSSION AND ACTION REGARDING PRESENTATION BY AND APPROVAL OF THE 2017 FISCAL YEAR FINANCIAL AUDIT BY CITY AUDITOR KEITH NEFFENDORF, NEFFENDORF & KNOPP PC.

City Auditor Keith Neffendorf presented the 2016-2017 fiscal year audit findings to the council. Council member Coleman made a motion to accept the audit as presented. Council member Guthrie seconded the motion. All were in favor and the motion passed.

7. DISCUSSION AND ACTION REGARDING ALLOCATION OF CARES ACT FUNDS TO JOHNSON CITY ISD FOR THE PURPOSE OF PURCHASING HOTSPOTS, CHROMEBOOKS, AND IPADS.

Mayor Stell gave background of the CARES Act funding. Superintendent Kolek talked about the TEA Project Connectivity bulk purchasing program and that TEA will match any funds contributed from local governments CARES funding. Councilmember Dildine made a motion to allow Mayor Rhonda Stell to issue a letter to JCISD confirming a donation of \$20,000 contingent to the City receiving the allocated funds for Texas Department of Emergency Management. Council Member Coleman seconded the motion. All were in favor and the motion passed.
