

Discussion of and action on a Resolution of the City Council of the City of Johnson City, Texas authorizing the appropriation of Interest & Sinking Funds for the replacement of three (3) Police Department vehicles and the purchase of the same through Ford Credit Municipal Finance in the maximum annual amount of Thirty-Eight Thousand Seven Hundred Forty Dollars and Twenty-two Cents (\$38,740.22) for a term of five (5) years; authorizing the Chief Administrative Officer / City Secretary to take all necessary steps to implement the provisions of this Resolution, including, but not limited to, the execution of related documents; incorporating recitals; providing for severability; and adopting an effective date.
