### August 2021

On 8/3/2021 we had a sewer line collapse at the corner of Pecan and Ave N. We blocked off the road that night and began work the next day. The excavation was slow due to avoiding water mains on both sides, and the depth of the sewer main. Although I had Todd and Larry their as well, at the end of the first day, we needed additional help. So, I called another crew in for Friday. By Friday night around 10:30 pm we had finished the job and the road was back open for the weekend.

8/9/2021 a 2-inch water main came apart on E Cypress and Ave F. To keep the customers with water, we chose to fix it without turning the water supply off. It took most of the day and had to remove the sidewalk before work could begin. The sidewalk has been replaced but I haven't repaired the street with asphalt.

The daily average discharge was 172,586 gal per day at the WWTP with no violations.

We pumped 6,700,000 gal of water for the month. The addition of reading unbilled meters won't come to light till the end of the month after billing.

### **Public Safety**

We had our August Court Docket. We had a minimal turnout, but we were productive with all cases.

Warrants were issued on those Defendants that did not show up. We sent Conviction Letters to any Show Cause Hearing "no shows". We will be able to issue Capias Pro Fine Warrants to said individuals after 30 days, if non-compliant. We want the Warrants issued prior to the February Warrant Round Up. The court issued a total of 24 warrants, and still going.

Judge and I will be discussing some City Ordinance Violation fines that were not previously set by our previous Judge. We have a few ordinance violations that have been issued and are being persued.

Our next bigger project will be how to handle the cases from Judge Riedel's hearings, in November & December, that were "no shows". Since we were not issuing warrants or FTAs at that time, these cases have remained stagnant. More than likely we will reset them with Judge Walston.

Our next docket is the last week of September.

We have closed out August with the City's incoming collections totaling \$3568.68 after the State's remittance. We disposed of 23 cases. 10 were "new" within the last 6 months (4 were dismissed by Compliance, DSC, or Deferred). 13 were "older" cases. 6 of the older cases were Dismissed with Plea Agreements with or without attorneys. One of those Defendants with 2 charges was proven Deceased. We started the month with 1310 pending cases, and ending with 1285.
