Whereas, the City of Johnson City, Texas, (hereinafter referred to as “City of Johnson City”) has been awarded federal funds under the American Rescue Plan Act, pursuant to Coronavirus State and Local Fiscal Recovery Fund (CSLFRF) Contract 167-TX8005 (TX1747) __;

Whereas, City of Johnson City, in consideration of the receipt and acceptance of these federal funds, hereby affirms its intention to comply with all federal rules, regulations and laws applicable to CSLFRF Contract 167-TX8005 (TX1747) with City of Johnson City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF JOHNSON CITY, TEXAS, THAT THE CITY OF JOHNSON CITY REAFFIRMS THE FOLLOWING:

1. In accordance with, Section 109 of the Title I of the Housing and Community Development Act. (24 CFR 6); the Age Discrimination Act of 1975 (42 U.S.C. 6101-6107); and Section 504 of the Rehabilitation Act of 1973 (29 U.S.C. 794) and for construction contracts greater than \$10,000, agrees to take actions to ensure that no person or group is denied benefits such as employment, training, housing, and contracts generated by the grant activity, on the basis of race, color, religion, sex, national origin, age, or disability;
2. Agrees to ensure that all federal rules and regulations including those rules and regulations governing citizen participation and civil rights protections are in place;
3. In accordance with, Section 3 of the Housing and Urban Development Act of 1968, as amended, and 24 CFR Part 135, is required, to the greatest extent feasible, agrees to provide training and employment opportunities to lower income residents and contract opportunities to businesses in the project area;
4. In accordance with, Section 104(1) of the Housing and Community Development Act, as amended, and State’s certification requirements at 24 CFR 91.325(b)(6), agrees to adopt an excessive force policy that prohibits the use of excessive force against non-violent civil rights demonstrations;
5. In accordance with Executive Order 13166, agrees to take reasonable steps to ensure meaningful access to services in federally assisted programs and activities by persons with limited English proficiency (LEP) and have an LEP plan in place specific to the locality and beneficiaries for each project;
6. In accordance with Section 504 of the Rehabilitation Act of 1973, asserts it does not discriminate on the basis of disability and agrees to ensure that qualified individuals with disabilities have access to programs and activities that receive federal funds;
7. In accordance with Section 808(e)(5) of the Fair Housing Act (42 USC 3608(e)(5)) agrees that any HUD programs and activities will be administered in a manner affirmatively to further the policies of the Fair Housing Act;
8. Agrees to maintain a written conflicts of interest policy consistent with 20 CFR Sec. 200.318(c);

9. Agrees to comply with Title VIII of the Civil Rights Act of 1968, 42 U.S.C. 3601, known as the Fair Housing Act;

For each Coronavirus State and Local Fiscal Recovery Fund contract or sub-contract, will assure that each sub-grantee, contractor, subcontractor, successor, transferee, and assignee shall comply with Title VI of the Civil Rights Act of 1964, which prohibits recipients of federal financial assistance from excluding from a program or activity, denying benefits of or otherwise discriminating against a person on the basis of race, color, or national origin (42 U S C.§ 2000d et seq.), as well as protections to persons with “Limited English Proficiency” implemented by the Department of the Treasury’s Title VI regulations, 31 CFR Part 22, which are herein
