Public Safety

On February 8th, Lt. Garrett Scallorn and Chief Ross Allen responded to 603 Ranchview Dr. in reference to a possible suicide. Upon arrival law enforcement personnel confirmed that a male subject at the residence was down with a gunshot wound to the head. Life saving measures were attempted but were not successful. Upon further investigation it was determined that the male subject had shot himself.

JCPD personnel are currently in the process of packing up the police station for our eventual move to city hall. We have had numerous individuals stop by the property to conduct walk throughs of the building.

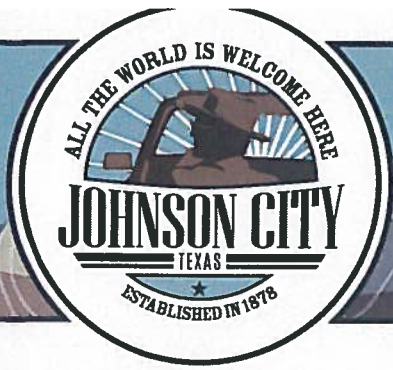
