EXECUTIVE	SUMMARY:			

The applicant / purchaser of the property located at 406 W. Main St., Johnson City, TX 78636 requests a change in zoning from "Public Facilities District" to "Commercial District" for the operation of a commercial office.

Following rezoning, the sale of the property will schedule for closing, hopefully by the end of next week. The property survey and title commitment policy have already been completed.

The Planning and Zoning Commission reviewed and recommended approval, as presented, of the proposed rezoning on April 26, 2022. As of May 2, 2022, City Staff has received no letters of opposition from the community.

## **FINANCIAL:**

The proceeds from the sale of the property will be deposited into the Capital Replacement Fund for future expansion of City Hall to accommodate the Police Department.
