EXECUTIVE SUMMARY:

For practical purposes, City Staff provides the following for Item Nos. 14 - 16, as all Items relate to the collection and disposal of solid waste within the City of Johnson City.

Item No. 14 -

Adds Article 13.07 Solid Waste Collection and Disposal to Chapter 13 Utilities of the Municipal Code of Ordinances. The Ordinance accomplishes the following:

- 1. Requires property owners / tenants to maintain their properties in compliance with the International Property Maintenance Code, including ensuring that each property is free and clear of dumped solid waste and recyclable materials.
- 2. Includes dumping prohibitions on private / vacant properties and public rights-of-way.
- 3. Provides civil and criminal penalties for violations.
- 4. Grants an exclusive franchise to a service provider selected by the City Council for the collection, removal, and disposal of solid waste and recyclable materials.
- 5. Requires a franchise agreement for any entity collecting solid waste refuse within the City.
- 6. Requires all residential, commercial, and industrial units / persons to utilize solid waste and recyclable material collection, removal and disposal services.
- 7. Provides for the City's billing and collection of fees from units / persons for the aforementioned services, including all commercial roll-off containers within the City.

Item No. 15 -

Establishes an exclusive franchise and contract between the City and Hill Country Waste Solutions for the collection and disposal of all solid waste and recyclable materials in the City limits. Generally, the contract includes the following:

- 1. June 1, 2022 June 1, 2025 initial term; automatic 3-year term renewals.
- 2. Provides insurance and performance bond requirements.
- 3. Residential services:
 - a. One (1) weekly curbside service, including cart and three (3) additional bags.
 - b. One (1) biweekly curbside recycling service, including cart.
 - c. Two (2) commingled curbside brush and white good / bulky item collections (8 cu. yds. each) per year.

4. Commercial / industrial services:

- a. A variety of hand cart / front load commercial containers at different service intervals for solid waste. See schedule of rates.
- b. A variety of hand cart / front load commercial containers at different service intervals for recyclable materials. See schedule of rates.
- 5. The following will not be picked up by the service provider as a part of regular service:
 - a. Construction and remodeling debris and other debris originating from commercial lot clearing and/or construction operations.
 - b. Brush items cut / trimmed by a commercial or private contractor.

- c. Bulky items and white goods resulting from work completed by a commercial or private contractor during bulky item pickup.
- 6. Municipal services provided at not cost to the City:
 - a. 360 cubic yards of compacted brush, trees and other plant materials trimmed and/or removed by the City from City rights-of-way and public drainage areas.
 - b. Regular solid waste collection and disposal services to City Hall and the Wastewater Treatment Plant (WWTP).
 - c. Regular solid waste collection and disposal services, including the replacement of clean plastic garbage bags, at all permanent, public trash receptacles throughout the City.
- 7. The City will be billed monthly by the service provider at the rates included in the Schedule of Rates for all residential, commercial, and industrial units in the City. The City will bill monthly all residential, commercial, and industrial units in the City in accordance with the City's Fee Schedule, as amended.
- 8. Service provider rates are locked for one (1) year from contract commencement. Thereafter, the rates are subject to a CPI adjustment. The service provider can also amend the Schedule of Rates for "unusual changes in the cost of operations;" however, the City may cancel the contract with 30 days written notice should the rate increase be considered unreasonable. Finally, the service provide can implement a fuel surcharge for fuel prices above \$3.70 per gallon. The fuel surcharge would be removed and discontinued following the fall of fuel prices below \$3.70 per gallon.
- 9. The service provider agrees to work with the City during emergency situations whereby the City must invoke its Emergency Management Plan (i.e. tornados, floods, et cetera).

Item No. 16 -

The proposed Ordinance amends the Municipal Fee Schedule to reflect:

- 1. The new rates charged to the customer. The rates are based upon those costs payable by the City to the service provider and the resulting fee increase, if applicable. Some fees remained the same, while others reflect the fee payable to the service provider, plus 10%.
- 2. The addition of a late payment charge of 10%, which has been previously applied in practice through utility billing.
- 3. The addition of a service reinstatement fee of \$35.00.

- 3. Replaces all water reconnection fees with one fee \$65.00 per reconnection.
