A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JOHNSON CITY, TEXAS AUTHORIZING THE SUBMISSION OF A TEXAS COMMUNITY DEVELOPMENT BLOCK GRANT (TXCDBG) FIRE, AMBULANCE, AND SAFETY TRUCKS (F.A.S.T.) PROGRAM APPLICATION TO THE TEXAS DEPARTMENT OF AGRICULTURE (TDA) FOR FIREFIGHTING VEHICLES, EQUIPMENT, AND RELATED ITEMS; AND AUTHORIZING THE CHIEF ADMINISTRATIVE OFFICER TO ACT AS THE CITY'S EXECUTIVE OFFICER AND AUTHORIZED REPRESENTATIVE IN ALL MATTERS PERTAINING TO THE CITY'S PARTICIPATION IN THE TEXAS COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM.

WHEREAS, the City Council of the City of Johnson City desires to develop a viable community, including decent housing, a suitable living environment, and expanding economic opportunities, principally for persons of low-to moderate income; and

WHEREAS, certain conditions exist which represent a threat to the public health and safety; and

WHEREAS, it is necessary and in the best interest of the City of Johnson City to apply for funding under the Texas Community Development Block Grant (TxCDBG) Fire, Ambulance, and Safety Trucks (F.A.S.T.) Program.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF JOHNSON CITY, TEXAS THAT:

Section One. Authorization. A Texas Community Development Block Grant Program application for the 2022 TxCDBG F.A.S.T. Program is hereby authorized to be filed on behalf of the City with the Texas Department of Agriculture.

Section Two. Application. The City's application be placed in competition for funding under the 2022 TxCDBG F.A.S.T. Program.

Section Three. Amount. The application be for \$750,000.00 of grant funds to provide fire service truck and fire-fighting equipment.

Section Four. Designee. The City Council directs and designates the following to act in all matters in connection with this application and the City's participation in the 2022 TxCDBG F.A.S.T. Program:

- The Chief Administrative Officer shall serve as the City's Executive Officer and Authorized Representative to execute this application and any subsequent contractual documents;
- The Chief Administrative Officer is authorized to execute environmental review documents between the Texas Department of Agriculture and the City; and
- If this application is funded, the Chief Administrative Officer is authorized to execute the Request for Payment Form documents and/or other forms required for requesting funds to reimburse project costs.

Section Five. Fund Use. All funds will be used in accordance with all applicable Federal, State, local, and programmatic requirements, including, but not limited to, procurement, environmental review, labor standards, real property acquisition, and civil rights requirements.

Section Six. Commitment. It further be stated that the City of Johnson City is committing \$7,500.00 from its General Fund as a cash contribution toward the administration, engineering, and/or construction activities of this fire service truck and fire-fighting equipment project.
