ORDINANCE NO. 22-0601

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF JOHNSON CITY, TEXAS SETTING A PUBLIC HEARING DATE ON UPDATES TO THE LAND USE ASSUMPTIONS AND CAPITAL IMPROVEMENTS PLAN AND THE IMPOSITION OF AN IMPACT FEE PER SERVICE UNIT ON JULY 26, 2022; AND ADOPTING AN EFFECTIVE DATE.

WHEREAS, Texas Local Government Code Chapter 395 Financing Capital Improvements Required by New Development in Municipalities, Counties and Certain other Local Governments requires the City of Johnson City to adopt an order establishing a public hearing date to consider updates to the land use assumptions and capital improvements plan and the imposition of an impact fee per service unit for the City

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF JOHNSON CITY, TEXAS THAT:

Section One. Public Hearing. A Public Hearing on updates to the land use assumptions and capital improvements plan and the imposition of an impact fee per service unit shall be held on July 26, 2022 at 6:00 p.m. C.S.T. at City Hall, 303 E. Pecan Drive, Johnson City, Texas 78636. Any member of the public shall have the right to appear at the Hearing and present evidence for or against the updates.
