Presentation by Anne Burger Entrekin, Regional Managing Director of Hilltop Securities, and discussion of and direction on the issuance of debt in the approximate amount of One Million, Five Hundred Thousand Dollars and No Cents (\$1,500,000.00) for street maintenance / improvement projects, including the following "complete streets" projects / activities:

- a. Removal / maintenance of vegetation;
- b. Repair / cleaning / maintenance / installation of drainage culverts and other drainage structures within rights-of-way;
- c. Repair / maintenance of existing sidewalks;
- d. Repair / maintenance / installation of street signage;
- e. Repair / maintenance / installation of street pavement; and

Council agrees to continue with fact finding process with an emphasis on public input.

12. Pursuant to Municipal Code of Ordinances Chapter One General Provisions, Article 1.02 Authority and Powers, Division Two Use of Official City Seal and Other Insignia, discussion of and action on requests by Mrs. Debbie Burkhard and Mr. / Mrs. Woody Gish to use the City logo for retail purposes, including, but not limited to, shot glasses, fabric shopping / tote / wine bags, magnets, and other souvenir items. (Applicant)

Councilmember Dildine made the motion to grant the use of the city logo to both parties (Burkhard and Gish). Councilmember Guthrie seconded the motion. Councilmember Fisher requested the motion to be amended to add a 6-month review of the use. Councilmember Dildine amended the motion and Councilmember Guthrie seconded the amended motion. All were in favor and the item was approved.

13. Discussion of and action on a Chapter 380 Economic Development Award and Loan Agreement between the City of Johnson City, Texas and Titan Milling, Inc. for the relocation of the entity's business operations to the City and the renovation of 401 E. Main St., Johnson City, Texas 78636 in the amount of Twenty-Five Thousand Dollars and No Cents (\$25,000.00). (Applicant)

Councilmember Babb made the motion to accept the agreement with the change to 6.15 to include the addition of a \$5,000 annual scholarship. Councilmember Fisher seconded the motion. All were in favor and the motion was approved.

14. Pursuant to Section 5 Management of Funds of a Hotel Occupancy Tax (HOT) Funding Agreement dated February 2021 between the City of Johnson City, Texas and the Johnson City Chamber of Commerce, discussion of and action on the Chamber's FYE 2023 HOT Fund Budget. (Chamber)

Councilmember Fisher made the motion to table the item. Councilmember Guthrie seconded the motion. All were in favor and the item was tabled.

15. Discussion of and action on casting votes for the Board of Trustees, Places 6 – 9, of the Texas Municipal League Intergovernmental Risk Pool. (TML-IRP)

Councilmember Babb made the motion to select Councilmember Fisher to place 9. Councilmember Guthrie seconded the motion. All were in favor and the motion was approved.

16. Presentation of and discussion on proposed City of Johnson City FYE 2023 Budget(s). (Council / Staff)

This was a discussion-only item. No action was taken.

Discussion of and action on a Resolution of the City Council of the City of Johnson City, Texas regarding a financing agreement for the purpose of procuring heavy equipment, including a backhoe loader and a trailer mounted Sludge Mate®, in the amount of Two Hundred Ninety-Seven Thousand, Seven Hundred Ninety-Four Dollars and Six Cents (\$297,794.06), for a term of four (4) (4.70%) or five (5) (4.75%) years with payments payable from the Vehicle & Equipment Replacement Program (VERP) Fund. (Staff)

Councilmember Dildine made a motion to approve the resolution regarding the financing agreement to procure heavy equipment for a five-year term and to be funded from the VERP fund. Councilmember Fisher seconded the motion. All were in favor and the resolution passed.

Discussion of and action on an Ordinance of the City Council of the City of Johnson City, Texas levying an ad valorem (property) tax rate for the Tax Year 2022 in the amount of \$0.356900 cents per one hundred dollars (\$100) valuation and directing the Blanco County Appraisal District to assess, account for, and distribute the ad valorem (property) taxes as herein levied; authorizing the Chief Administrative Officer to take all necessary steps to implement the provisions of this Ordinance; incorporating recitals; providing for severability; repealing any other Code provisions, ordinances, or parts of ordinances, and other provisions in conflict herewith; and setting an effective date. (Staff)

Councilmember Fisher moved that the property tax rate be increased by the adoption of a tax rate of \$0.356900 per \$100 valuation, which is effectively a 14.65% increase in the tax rate. This motion includes:

- 1) the adoption of an ad valorem (property) tax rate for the Maintenance and Operations expenditures of the City of Johnson City at \$0.249200 cents per \$100 valuation for the Tax Year beginning January 1, 2022 and ending December 31, 2022; and
- 2) the adoption of an ad valorem (property) tax rate for the principal and interest payable on the Interest and Sinking (debt service) expenditures of the City of Johnson City at \$0.107700 cents per \$100 valuation for the Tax Year beginning January 1, 2022 and ending December 31, 2022.

Councilmember Guthrie seconded the motion.
