Public Works Report March 2023

For the month of March 2023, the average daily discharge at the Wastewater Treatment Plant was 202,000 gallons of effluent per day with no violations. We continue to monitor the Plant's influent in preparation of a future Plant expansion.

SCADA system hardware is still being installed. Currently, all wells are tied into the new system, but the contractor, Trac-n-Trol is waiting for water meters to arrive. Final software calibration will occur after the meters are installed.

The new sludge drying trailer has been delivered, and the Department is currently adjusting (to polymer mixture) the equipment. The trailer works well.

In February 2023, the Department failed to send a water bacteriological sample to the laboratory. I confirmed this failure with the Texas Commission on Environmental Quality (TCEQ), and TCEQ will send a violation letter shortly. The Department will be back in compliance as soon as the sample taken on March 15, 2023 has been published and notification letters are sent out. The laboratory sends TCEQ lab results on a monthly basis, but we receive them as soon as they have been processed.

Public Safety

Officer Kris Greenhill made two Driving While Intoxicated arrests during the month of March. In both cases the driver refused to submit to a breath test and a blood warrant was obtained. These specimens have both been sent to the Texas DPS Crime Lab for analysis.

On March 19th, Officer Jessica Oestreich received a call to LBJ High School in reference to a criminal mischief. When she arrived and met with District Superintendent Richard Koleck it was determined that three separate buildings had been broken into on the school district property. During these burglary's multiple items were stolen and the property damage was extensive. JCISD estimated the damages to be around \$28,000.00. In the days following this crime the Johnson City Police Department received several Crime Stoppers Tips of possible involved parties. On March 21st Lt. Garrett Scallorn received a phone call from a possible suspect who wanted to turn himself in. Lt. Scallorn met with this individual later that day and he confessed to his part of the offenses and also gave names of three others who were involved. On March 22nd Officer Ethan Bishop met with and interviewed two other suspects who also confessed to taking part in the burglaries and property damage. On March 24th Lt. Scallorn along with two Investigators from US Army's Office of Criminal Investigations met with the fourth suspect and he confessed

to his part in the crimes. This Federal Agency assisted due to the suspects affiliation as a soldier in the United States Army. Over the weekend of March 25th and 26th Lt. Scallorn typed up and obtained arrest warrants for the four suspects and on Monday March 27th all four turned themselves into the Blanco County Jail. This case will be submitted to 33rd Judicial Districts District Attorneys Office for prosecution.
