**A RESOLUTION OF THE CITY OF JOHNSON CITY, TEXAS  
CANVASSING THE RETURNS AND DECLARING THE RESULTS OF  
THE GENERAL ELECTION HELD SATURDAY, MAY 6, 2023 FOR THE  
PURPOSE OF ELECTING A MAYOR.**

**WHEREAS**, a General Election was held in the City of Johnson City, Texas on May 6, 2023 for the purpose of electing a Mayor; and

**WHEREAS**, said election was duly and legally held in conformity with the election laws of the State of Texas, and the results of said election have been verified and returned by the proper judges and clerks; and

**WHEREAS**, Section 67.003 of the Texas Election Code, as amended, generally provides that each local canvassing authority shall convene not later than the eleventh (11<sup>th</sup>) day after the May election date for the purpose of canvassing the election results; and

**WHEREAS**, Section 67.004(a) of the Texas Election Code, as amended, establishes that two members of the authority constitute a quorum for purposes of canvassing an election.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF JOHNSON CITY, TEXAS THAT:**

**Section One.** The facts and matters set forth in the preamble of this Resolution are hereby found to be true and correct.

**Section Two.** The official canvass of the returns of the General Election held on May 6, 2023 reflects that the following named persons received the number of votes set opposite their names in the respective positions to be filled:
