

## Public Works Report August 2023

The Utility Department discharged an average of 101,000 gallons of effluent per day at the Wastewater Treatment Plant with no violations.

Billed water use was 6,431,930 gallons; pumped water was 8,820,000 gallons, with an average of 294,000 gallons per day and 9 hrs. of run time on the wells per day.

The well depth draw down has not changed and the gallons per minute is steady, according to the SCADA system.
