The Wastewater Treatment Plant discharged approximately 130,000 gallons of effluent per day, with no violations.

We metered 4,500,000 gallons of water and pumped 10,400,000 gallons of water during the billing cycle, which equates to an approximate loss ratio of 57% from 12-19-23 to 1-22-24.

Three DWI arrests were made in the month of January. Two by Officer Kris Greenhill and one by Officer Wiggins. Blood warrants were obtained during the three arrests and those specimens have been submitted to the Texas DPS Crime Lab for analysis.

JOHNSON CITY POLICE DEPT. has adopted a detailed written policy on racial profiling. Our policy:

- 1) clearly defines acts constituting racial profiling;
- 2) strictly prohibits peace officers employed by the JOHNSON CITY POLICE DEPT. from engaging in racial profiling;
- 3) implements a process by which an individual may file a complaint with the JOHNSON CITY POLICE DEPT. if the individual believes that a peace officer employed by the JOHNSON CITY POLICE DEPT. has engaged in racial profiling with respect to the individual;
- 4) provides public education relating to the agency's complaint process;
- 5) requires appropriate corrective action to be taken against a peace officer employed by the JOHNSON CITY POLICE DEPT. who, after an investigation, is shown to have engaged in racial profiling in violation of the JOHNSON CITY POLICE DEPT. policy;
- 6) requires collection of information relating to motor vehicle stops in which a warning or citation is issued and to arrests made as a result of those stops, including information relating to:
  - a. the race or ethnicity of the individual detained;
  - b. whether a search was conducted and, if so, whether the individual detained consented to the search;
  - c. whether the peace officer knew the race or ethnicity of the individual detained before detaining that individual;
  - d. whether the peace officer used physical force that resulted in bodily injury during the stop;
  - e. the location of the stop;
  - f. the reason for the stop.
- 7) requires the chief administrator of the agency, regardless of whether the administrator is elected, employed, or appointed, to submit an annual report of the information collected under Subdivision (6) to:
  - a. the Commission on Law Enforcement; and
  - b. the governing body of each county or municipality served by the agency, if the agency is an agency of a county, municipality, or other political subdivision of the state.

The JOHNSON CITY POLICE DEPT. has satisfied the statutory data audit requirements as prescribed in Article 2.133 (c), Code of Criminal Procedure during the reporting period.
