# CHARTER TOWNSHIP OF KALAMAZOO BOARD OF TRUSTEES SPECIAL MEETING Monday, November 21, 2022

The Board of Trustees of the *Charter Township of Kalamazoo* held a Special Meeting on <u>Monday, November 21, 2022,</u> at <u>6:00 p.m.</u> in the Board Room of the Charter Township of Kalamazoo Administration Building, 1720 Riverview Drive, Kalamazoo, MI 49004, for the purpose of considering a Consent Agenda, hearing a presentation by a terminated employee, and any other business that may legally come before the Board of Trustees of the Charter Township of Kalamazoo, Kalamazoo County.

PRESENT: Supervisor Donald Martin, Clerk Mark Miller, Treasurer Sherine Miller, Trustees

Steven Leuty, Ashley Glass, Lisa Moiaery and Clara Robinson.

**ABSENT**: None.

ALSO PRESENT: Acting Fire Chief Mike Weidemann and Manager Dexter Mitchell.

#### Item 1 – CALL TO ORDER

Supervisor Martin called the meeting to order at 6:00 p.m.

#### <u>Item 2 – ROLL CALL OF BOARD MEMBERS</u>

All members present.

#### **Item 3 – PUBLIC COMMENT**

Mike Weidemann 1310 Nichols said we have had an injustice and need to reinstate the Chiefs.

Nancy Kowalski has experience working with the two Chiefs and attests to their character.

Connie Butler on Mulhearn asks the Board to listen.

Joey Bird on Edison St. attests to the Chiefs working to serve the community.

Mike Rogers on Chapparel spoke to the character of the Chiefs and that they have never expressed racism.

Todd Kowalski said the people present at the meeting are neighboring firefighters as well.

Christian has not met the Chiefs but has seen Emergency Room work. The professionalism of our Fire Department comes from the top.

Mae Meeth, attending over Zoom, attempted to make a comment but technical difficulties prevented it. She sent her comments by email, expressing that Chief Mulac did not deserve to speak, and his firing was justified.

### <u>Item 4 – CONSENT AGENDA</u>

Chief Weidemann gave the names of newly hired on-call firefighters:

A. Approve the Hiring of Daniel Hardenbrook and Kirsten Scheller at Station 2, Shane Peterson, Khaleb Critinger, and Allen Martensen at Station 1 as on-call firefighters.

Clerk Miller moved adoption of the Consent Agenda, seconded by Trustee Leuty. Voice vote, motion carried.

## <u>Item 5 – PRESENTATION BY A TERMINATED EMPLOYEE</u>

Former Battalion Chief Matt Mulac spoke about the circumstances leading to his termination by the Township Manager. Mr. Mulac thanked the board for voting to hear him.

His employment began in 1997, and he was appointed Battalion Chief in 2012 at Station 2. It was an honor to serve a diverse community. All were given honor and respect. All employees were treated equally and with good faith.

The training he received in HR was general and not specific to the job he was asked to do.

The core of his administrative responsibilities were policies and objective facts.

SOGs are updated continually. SOGs are given to all firefighters annually. (3 handouts were provided to the Board)

In December 2019, he was informed of a complaint. (Provided to Board as a handout)

On December 3, 2019, the complainant told Mulac her complaint. He asked her to write it out. (Provided as a handout) The SOGs required facts. He has had family and friends who were victims of workplace violence. The action was taken to address the situation. He could have used the situation as an excuse to get rid of a troublesome employee. The interviews did not allow him to make factual determinations of the complainant's claims. Both the accuser and accused were addressed in his office and provided with copies of documents.

The same complainant asked for a leave of absence in 2022. All seemed well. He inquired as to the circumstances of her request. She asked for 90 days. Jared Alexander appeared in March 2022 and had interrogated about additional allegations. He was informed he could not talk about the investigation to any of his personnel. We continue to trust that the truth will be exposed

It was assumed that all were informed, which turns out to be false. We took action to make sure the situation would not recur.

He met on April 13 with Labor Attorney McCamman. This was uncomfortable and humiliating. Kurt said this was to evaluate the Township's exposure to liability risk. The investigation was completed. Yet months later he had not been told anything more.

Attorney Codie Burt shared information concerning Trustee Glass' communication to the Manager.

Mulac resumed speaking about Trustee Glass.

He was in awe as to how the three-page list of allegations had expanded.

Attorney Burt spoke to the transcript of the pre-determination hearing. The predetermination memo is filled with false facts. Throughout the hearing, the Manager chose to continue to interrogate her client. The Manager twisted the words "tight-knit". Timely reporting is key. Mulac's 24-hour turnaround in the initial investigation is good.

Mulac continued that nothing happened for months. Why did the Manager wait?

A termination letter was given to him on Sept. 14, and the station was left unstaffed. He notified dispatch that the station was out of service.

He continues to fight to clear his name.

Where are the investigator's notes and conclusions?

The Board must find the resolve to remove the Manager.

Mike on Iroquois in Westwood is concerned about the fire service, the actions of the Board, the Manager and Trustee Glass. The firing was unprofessional. The Chiefs should be reinstated

Connie Butler on Mulhearn thanked the Board for listening to Matt Mulac at the recent Special Meeting. The Chiefs should be brought back.

## Item 9A REQUEST TO APPROVE REZONING ORDINANCE FOR 3800 GULL ROAD

Attorney Seeber said the Planning Commission has held a public hearing. A site plan was approved.

Trustee Leuty moved to adopt Ordinance 631, rezoning 3800 Gull Road from C-1 Local Commercial District to C-2 Commercial Corridor District, seconded by Trustee Moaiery, (7-0), Motion carried.

## Item 9C REQUEST TO APPROVE FIREFIGHTER PROTECTIVE EQUIPMENT PURCHASE

Chief Weidemann said that this will come from capital, the gear should last ten years. It will cost \$30,527.00.

Trustee Moaiery moved to approve purchase of Firefighter Protective Equipment for a total of \$30,527, supported by Trustee Robinson. Roll call vote, (7-0), Motion carried.

## Item 9D REQUEST TO APPROVE THE PROPOSAL FOR EVALUATION OF THE TOWNSHIP MANAGER

Trustee Leuty explained that the Board had rescheduled this item from our last Regular Meeting. The instrument is based on the Manager's agreement and goals, and our Strategic Plan calls for it to happen

#### Trustee Leuty moved to approve the proposal, seconded by Clerk Miller.

Robinson agrees that the Manager should have an evaluation. The timing is sensitive, but we do have a job to do. All employees should be evaluated. We also should have exit interviews.

Supervisor Martin said all other employees are being evaluated.

Treasurer Miller said we don't know what we don't know. She feels that the employees should have the opportunity to express their opinion.

Trustee Glass agrees with the previous statements. She thinks we should use best HR practices in evaluations.

Roll call vote, (7-0), Motion carried.

## Item 9E CONSIDERATION OF REQUEST FOR TERMINATED EMPLOYEE TO BE HEARD BY THE BOARD

The Board received a request through Attorney Seeber from a terminated employee requesting to address the Board.

Trustee Leuty moved to approve a special meeting of the Township Board for December 5, 2022, at 6 p.m. to provide a recently-terminated employee to be heard by the Board, without the Board participating in a dialog or asking questions of the employee, seconded by Supervisor Martin.

Trustee Moaiery had problems with the last hearing. The Board did not have legal representation. She did not like that accused people did not have the opportunity to respond.

Trustee Leuty said by requiring the board not to respond makes it like a public comment.

Trustee Robinson replied that we did not have legal representation due to Attorney Seeber being unavailable. She still owes a lot of people phone calls. As hard as it is to listen to all that, we have set a precedent. We should not deny it for the other fired employee.

Clerk Miller said a general conversation is impossible due to legal constraints.

Trustee Moaiery said we are opening ourselves up for liability. She wants us to make the right decision but does not agree with the process. She hopes we will have a public comment period at the end and fix our Zoom problem.

Trustee Leuty said Codie Burt told us she knows we are still working on the issue. We are not acting as an Appeals Board by hearing the employee.

Treasurer Miller asked whether we would have legal counsel on December 5? Attorney Seeber replied if we are just listening, there does not appear to be a need for counsel to be present.

Roll call vote, (5-2 Glass, Moaiery), Motion carried.

## <u>ITEMS REMOVED FROM THE CONSENT AGENDA</u>

Street Name Confirmations. Treasurer Miller was confused about the name changes. What are we changing? Old Riverview does affect nine parcels. We will need to spend on maps to reflect the changes. It also affects the residents involved.

Supervisor Martin asked the attorney whether we had to accept the changes? Attorney Seeber said we should find the reason for the change. Manager Mitchell does not know why this is being done.

Treasurer Miller said it is already named Old Riverview, just not on the maps and in our database. Residents will need to do some work to make the change.

### Item 11 BOARD MEMBER REPORTS

Trustee Leuty said Rollie Leathers passed away, one of the founders of the Wilson Recreation Area. He thanked Elizabeth Kowalski for her service in the Township Office. Second leaf pickup starts next week. He read "The Righteous Mind", we subconsciously apply our moral judgments. The best we can do is to pause a few minutes before responding, and seek common values.

Trustee Glass is disappointed in how the Board has acted in unprecedented ways. The listening session was a farce. Her entire time on the Board has been wrapped up in inter-personal conflicts. She encourages the public to come out and find out what is going on. It is very disheartening to see how the Board has acted. She does not understand how we have come to this point.

Trustee Robinson reported on PAC Committee meeting, she agrees we have a number of large tasks ahead. We need to set priorities. She did not realize the amount of work required. She will not understand everyone's point of view; however she will do her best. There is also room for growth for members who have been here a long time. She encouraged residents to clear out snow from fire hydrants and sidewalks.

Clerk Miller agreed with Trustee Robinson's remarks. He shared statistics from the recent election.

Treasurer Miller is concerned about lack of communication. PAC Committee met but has not reported to the Board. It seems that things not being addressed quickly enough. She hopes we can work on being more informed.

Supervisor Martin said the PAC Committee is still working. He thanked PMN for being here. Everyone is interested in what is happening.

## Item 12 ATTORNEY'S REPORT

None.

### Item 13 MANAGER'S REPORT

Manager Mitchell will test to see if Zoom is fixed. We will be looking at Board of Review. We are updating our insurance contract. Dec. 9 will be the Christmas Party.

#### Item 14 PUBLIC COMMENT

Todd Kowalski repeated his thanks to Trustee Robinson. Exit interviews are a farce. Communication has not happened since Sept. 14. Manager has not communicated with the Fire Department.

Connie Butler addressed Trustee Moaiery's comment that accusations were made without a chance to respond. This is what happened to the Chiefs.

Mike Rogers talked about dialog, it looks like we want to stifle them.

# **SECTION I**

# AMENDMENT TO SECTION III "DEFINITIONS" OF ORDINANCE NO.(551, AS AMENDED

Subsection 4 of Section III "Definitions" of Ordinance No.551, as amended known and cited as the Kalamazoo Charter Township Rental Properties Registration, Maintenance, and Inspection Ordinance is hereby amended to read as follows:

"4. Rental Dwelling" shall mean a dwelling containing one or more rental housing units. A "Rental Dwelling" for the purposes of this ordinance does not include a church parsonage or a state-licensed child or adult care home".

#### **SECTION II**

# AMENDMENTS TO SECTION IV "REGULATIONS" OF ORDINANCE NO. 551, AS AMENDED

- 1. Section IV "Regulations" of Ordinance No. 551, as amended subsection B. is hereby amended to read
  - "B. Shall not constitute a dilapidated, unsafe or dangerous building under the provisions of the Kalamazoo Charter Township Dangerous Buildings Ordinance according to the Township's Building Official."
- 2. Subsections F. G. and H. of Section IV "Regulations" of Ordinance No. 551, as amended are hereby amended to read:
  - "F. All electrical systems and wiring must be in proper working order and adequate for the electricity service expected therefrom.

- G. A sanitary water supply and an adequate supply of hot, potable water shall be available within the interior of the rental dwelling for the convenient and safe use of all the occupants thereof.
- H. The entire premises shall be free of any hazardous or unsafe condition caused by any structural failure, deterioration or disrepair, unguarded openings or unhealthful or unsanitary activities or circumstances which would be injurious to the occupants thereof or to any other persons in or property in and about the premises".
- 3. Section IV, "Regulations" of Ordinance No. 551, as amended, is hereby amended by the elimination of Subsection IV. I.

# **SECTION III**

# AMENDMENTS TO SECTION V "REGISTRATION" OF ORDINANCE NO. 551, AS AMENDED

- 1. All of the wording in subsection B of Section V of Ordinance No. 551, as amended, is hereby eliminated.
- 2. Former subsection C. of Section V and provisions 1-3 following are hereby renumbered to subsection B and provisions 1-3, respectively.
- 3. Paragraph V. C. is hereby amended by the elimination of the reference to "township treasurer or his/her designee" and is otherwise retained.
- 4. Subsection B. 3. of Section V "Registration" of Ordinance No. 551, as amended is hereby amended to read as follows; "3. Mobile Homes and owner-occupied units of a duplex or tri-plex shall not require registration. Non-owner-occupied units in duplexes and triplexes are required to be registered".
- Former Subsection D. of Section V and provisions 1-2 therein are renumbered to Subsection C. of Section V and provisions 1-2 of Ordinance No. 551, as amended.
- 6. Subsection C. provisions 3-7 of Ordinance No.551, as amended are hereby added to read as follows:
  - "3. The number and location of off-street parking spaces available for the rental dwelling.
  - 4. The total number of housing rental units under one roof in a duplex; triplex or quad-plex.
  - 5. A declaration that the maximum number of tenants the owner will allow to occupy the rental dwelling will not exceed the number permitted by the building code and zoning ordinance.
  - 6. An agreement by the owner to permit the inspections provided for under this ordinance.
  - 7. Any other relevant information required by resolution of the Township Board."
- 7. Subsections D, E and F of Section V of Ordinance No. 551, as amended are hereby amended to read as follows:

- "D. A Rental Registration Application shall not be accepted by the Township unless it is signed in ink and accompanied by the application fee.
- E. Rental Registration does not constitute approval of the rental dwelling or any specific uses and such rental dwelling and uses remain subject to the requirements of all township ordinances.
- F. Rental Registrations shall apply for a calendar year and cover a period of January 1- December 31. A Rental Registration Renewal Application shall be submitted to the Township prior to expiration and shall be submitted and acted upon using the same process as set forth in subsections B and C, above. The Township shall send an application for renewal to the owner or legal agent, if any, at least thirty days prior to expiration. In the event of a transfer of ownership, the Registration shall expire and the new owner shall immediately submit to the Township Treasurer or his/her designee an application for Rental Registration."
- 8. Former subsection H. of Section V of Ordinance No. 551, as amended are hereby renumbered to Section V, G.
- 9. Subsections H and I of Section V of Ordinance No. 551, as amended are hereby eliminated.

## **SECTION IV**

# AMENDMENT TO SECTION VII "INSPECTIONS" OF ORDINANCE NO. 551, AS AMENDED

- The first paragraph of Section VII "Inspections" of Ordinance No. 551, as amended is hereby amended by the removal of the phrase "The Construction Code Enforcing Agency shall make initial inspection of all new rental units and renewed rental units as described in Section V. F. of this Ordinance"; and by the removal of the phrase "two (2) year inspection period".
- 2. The second paragraph of Section VII "Inspections" entitled "Inspection Fees" of Ordinance No. 551, as amended is hereby amended to read as follows:
  - "Rental Inspection Fees". Rental property inspection fees by the Construction Code Enforcing Agency are charged per rental unit to the Township. The Township shall be reimbursed by the owner of each said unit for any inspection fee incurred for that unit. The Township Board shall, by resolution, establish the rental property inspection fees approximating that charged by the Construction Code Enforcing Agency and an administrative surcharge not to exceed 25% of that charged to the township by the Construction Code Enforcing Agency. Inspection fees incurred by the Township shall be invoiced to the owner of the building and shall be paid within 30 days. Failure to pay an inspection fee shall be deemed to be a violation of this Ordinance.

# **SECTION V**

# AMENDMENT TO SECTION IX "VIOLATION" OF ORDINANCE NO. 551, AS AMENDED

- A. Section IX "Violation" of Ordinance No. 551, as amended is hereby amended by the elimination of each phrase of "within a 3-year period" and by the elimination of the sentence "Determined on the basis of the date of commission of the offense(s)."
- B. Section IX "Violation" of Ordinance 551, as amended, is hereby further amended by eliminating the preceding dashes in the offense and fine columns.

# **SECTION VI**

## **VALIDITY**

The provisions of this Ordinance are hereby declared to be severable and if any clause, sentence, word, section or provision is hereafter declared void or unenforceable for any reason by any Court of competent jurisdiction, it shall not affect the remainder of such ordinance which shall continue in full force and effect.

## **SECTION VII**

# REPEAL OF CONFLICTING ORDINANCES

Conflicting provisions of Ordinance No. 551, as amended are hereby repealed.

**SECTION I** 

TITLE

This Ordinance shall hereafter be referred to and cited as the "Kalamazoo Charter Township Rental Properties Registration, Maintenance and Inspection Ordinance."

## **SECTION II**

#### **PURPOSE**

The purpose of the within Ordinance is to protect the health, safety and general welfare of the residents and property owners within the Township by requiring the registration of all rental dwellings and requiring certain minimum standards to be maintained with respect to the condition of rental dwellings within the Township which, because of absentee ownership, may tend to become in disrepair, unsightly, unsafe, or unsanitary.

#### **SECTION III**

#### **DEFINITIONS**

For purposes of this Ordinance, the terms set forth below shall have the following meanings:

- The terms and definitions of "dwelling", "dwelling unit", "one-family dwelling", "two-family dwelling", "multiple dwelling" and "family" as set forth in the Kalamazoo Charter Township Zoning Ordinance are incorporated herein by reference. Additionally, the term "dwelling" shall for purposes of this Ordinance be deemed to include a mobile home regardless of whether it meets all of the standards set forth in the definition of "dwelling" in the Kalamazoo Charter Township Zoning Ordinance.
- "Building Official" shall mean the Building Official of the Charter Township of Kalamazoo.
- "Person" shall mean an individual, corporation, partnership, limited liability company or other legal entity.
- "Rental Dwelling" shall mean a dwelling containing one or more rental 4. housing units. An apartment complex and a manufactured (mobile) home park consisting of one or more buildings under common ownership and on the same parcel of land shall be considered one rental dwelling for purposes of this Ordinance. A "Rental Dwelling" for the purposes of this ordinance does not include a church parsonage or a state-licensed child or adult care home.
- "Rental housing unit" shall mean a dwelling unit in which one or more occupants thereof are not the owner(s) of the premises on which the unit is situated and consideration is paid in exchange for the right to reside therein (i.e., a dwelling unit which is not solely occupied by the owner of the premises and his/her family).
  - 6. "Township" shall mean the Charter Township of Kalamazoo.

#### **SECTION IV**

#### REGULATIONS

It shall hereafter be unlawful for any owner of a rental dwelling, regardless of the nature of the ownership thereof, to lease or rent the same during any period that it fails to meet the following minimum standards:

- C. Its roof, walls, windows and doors are substantially leak and weather proof so as to prevent drafts and interior abnormal moisture.
- D. It is furnished with an operable and safe furnace or heating system adequate to maintain the premises at a temperature of not less than 68 degrees Fahrenheit during sub-zero weather conditions.
- E. It is supplied with plumbing and sanitary sewage systems in proper working condition and without consequent pollution or contamination.
- F. All electrical systems and wiring must be in proper working order and adequate for the electricity service expected therefrom.
- F. An adequate sanitary supply of water is available within the rental dwelling free of any contamination or pollution.
- G. A sanitary water supply, and Anan adequate supply of hot, potable water shall be available within the interior of the rental dwelling for the convenient and safe use of all the occupants thereof.
- H. The entire premises shall be free of any hazardous or unsafe condition caused by any structural failure, deterioration or disrepair, unguarded openings or unhealthful or unsanitary activities or circumstances which would be injurious to the occupants thereof or to any other persons in or property in and about the premises.

#### **SECTION V**

#### **REGISTRATION**

- A. No dwelling shall be leased or occupied in whole or in part for rental purposes unless it is first registered with the Township as provided in this Ordinance.
- B. A separate registration and fee shall be required for each building within a multibuilding complex.
- Occupancy of any dwelling by anyone other than the owner of record and his/her family shall be presumed to require registration under this Ordinance.

  - Name, driver's license or state identification number (or, in the case of a corporation, the corporate ID number), permanent home address, and business and home telephone number of:
    - (a) The owner:
    - (b) The legal agent designated by the owner, if any; and
    - (c) The resident agent, individual partner, or managing member of any business entity.
  - The street address(es) of the rental dwelling.
  - The Zening District classification within which the rental dwelling is located.

**SECTION I** 

TITLE

This Ordinance shall hereafter be referred to and cited as the "Kalamazoo Charter Township Rental Properties Registration, Maintenance and Inspection Ordinance."

# **SECTION II**

# <u>PURPOSE</u>

The purpose of the within Ordinance is to protect the health, safety and general welfare of the residents and property owners within the Township by requiring the registration of all rental dwellings and requiring certain minimum standards to be maintained with respect to the condition of rental dwellings within the Township which, because of absentee ownership, may tend to become in disrepair, unsightly, unsafe, or unsanitary.

# **SECTION III**

# **DEFINITIONS**

For purposes of this Ordinance, the terms set forth below shall have the following meanings:

- 1. The terms and definitions of "dwelling", "dwelling" unit", "one-family dwelling", "two-family dwelling", "multiple dwelling" and "family" as set forth in the Kalamazoo Charter Township Zoning Ordinance are incorporated herein by reference. Additionally, the term "dwelling" shall for purposes of this Ordinance be deemed to include a mobile home regardless of whether it meets all of the standards set forth in the definition of "dwelling" in the Kalamazoo Charter Township Zoning Ordinance.
- 2. "Building Official" shall mean the Building Official of the Charter Township of Kalamazoo.
- 3. "Person" shall mean an individual, corporation, partnership, limited liability company or other legal entity.
- 4. "Rental Dwelling" shall mean a dwelling containing one or more rental housing units. A "Rental Dwelling" for the purposes of this Ordinance does not include a church parsonage or a state-licensed child or adult child care home.
- 5. "Rental housing unit" shall mean a dwelling unit in which one or more occupants thereof are not the owner(s) of the premises on which the unit is situated and consideration is paid in exchange for the right to reside therein (i.e., a dwelling unit which is not solely occupied by the owner of the premises and his/her family).
  - 6. "Township" shall mean the Charter Township of Kalamazoo.

# **SECTION IV**

# **REGULATIONS**

It shall hereafter be unlawful for any owner of a rental dwelling, regardless of the nature of the ownership thereof, to lease or rent the same during any period that it fails to meet the following minimum standards:

A. The minimum requirements of the Michigan Construction Code to the extent the Code is applicable thereto or, in the case of a mobile home, the mobile home construction standards that are applicable to the mobile home under the National Manufactured Housing Construction and Safety Standards Act of 1974, 42 USC 5401 to 5426, or standards or codes to which the mobile home was constructed if it was constructed before application of the National Manufactured Housing Construction and Safety Standards Act of 1974.

- B. Shall not constitute a dilapidated, unsafe or dangerous building under the provisions of the Kalamazoo Township Dangerous Buildings Ordinance according to the Township's Building Official.
- C. Its roof, walls, windows and doors are substantially leak and weather proof so as to prevent drafts and interior abnormal moisture.
- D. It is furnished with an operable and safe furnace or heating system adequate to maintain the premises at a temperature of not less than 68 degrees Fahrenheit during sub-zero weather conditions.
- E. It is supplied with plumbing and sanitary sewage systems in proper working condition and without consequent pollution or contamination.
- F. All electrical systems and wiring must be in proper working order and adequate for the electricity service expected therefrom.
- G. A sanitary water supply; and an adequate supply of hot, potable water shall be available within the interior of the rental dwelling for the convenient and safe use of all the occupants thereof.
- H. The entire premises shall be free of any hazardous or unsafe condition caused by any structural failure, deterioration or disrepair, unguarded openings or unhealthful or unsanitary activities or circumstances which would be injurious to the occupants thereof or to any other persons in or property in and about the premises.

# **SECTION V**

# **REGISTRATION**

- A. No dwelling shall be leased or occupied in whole or in part for rental purposes unless it is first registered with the Township as provided in this Ordinance.
- B. Occupancy of any dwelling by anyone other than the owner of record and his/her family shall be presumed to require registration under this Ordinance.
  - This presumption may be rebutted by evidence that the occupant has ownership equity of 25% or more of the fee or life estate evidenced by:
    - (a) A recorded deed, or;
    - (b) A recorded land contract; or
    - (c) An unrecorded land contract with supporting evidence that it was not entered into in order to circumvent the requirements of this Ordinance, including subsequent recordation.

- 2. Occupants of any dwelling claiming any form of ownership, in accordance with a land contract, option to purchase or any other legal instrument shall provide proof that the transfer of ownership is supported by substantial equity interest in the property by the person or persons claiming ownership.
- 3. Mobile homes and owner-occupied units of a duplex or tri-plex shall not require registration. Non-owner-occupied units in duplexes or tri-plexes are required to be registered.
- C. Applications for Rental Registration shall be submitted to the Township along with an Application Fee established by resolution of the Township Board, which shall approximate the costs to the Township of maintaining the registration program and which is separate from Construction Code Enforcing Agency inspection fees. The Rental Registration application shall be made on forms provided by the Township. The forms shall be signed by the owner or the owner's legal agent, if any, and include the following:
  - 1. Name, driver's license or state identification number (or, in the case of a corporation, the corporate ID number), permanent home address, and business and home telephone number of:
    - (a) The owner;
    - (b) The legal agent designated by the owner, if any; and
    - (c) The resident agent, individual partner, or managing member of any business entity.
  - 2. The street address(es) of the rental dwelling.
  - 3. The number and location of off-street parking spaces available for the rental dwelling.
  - 4. The total number of rental housing units under one roof in a duplex, tri-plex or quad-plex.
  - 5. A declaration that the maximum number of tenants the owner will allow to occupy the rental dwelling will not exceed the number permitted by the building code and zoning ordinance.
  - 6. An agreement by the owner to permit the inspections provided for under this Ordinance.
  - 7. Any other relevant information required by resolution of the Township Board.

D. A Rental Registration application shall not be accepted by the Township unless it is signed in ink and accompanied by the application fee.

E. Rental Registration does not constitute approval of the rental dwelling or any specific uses and such rental dwelling and uses remain subject to the requirements

of all Township ordinances.

F. Rental Registrations shall apply for a calendar year and cover a period of January 1 – December 31. A Rental Registration Renewal Application shall be submitted to the Township prior to expiration and shall be submitted and acted upon using the same process as set forth in subparagraphs B and C above. The Township shall send an application for renewal to the owner or legal agent, if any, at least thirty days prior to expiration. In the event of a transfer of ownership, the Registration shall expire and the new owner shall immediately submit to the Township an application for Rental Registration, if any, and shall notify the Township of any change of the mailing address and telephone number of the owner within ten (10) working days of the date of the change.

G. The owner shall notify the Building Official or his/her designee of any change in the owner's designated legal agent, including the name, mailing address and

telephone number within ten (10) working days of the date of the change.

Subscriber shall notify EPS prior to the effective date of the increase if the Subscriber is unwilling to pay any such increased charge. If Subscriber timely provides such notice to EPS, EPS has the option of rescinding the increase and continuing with the contract, or terminating the contract. Any advance payments made for service to be supplied subsequent to the date of such termination shall be refunded to the Subscriber.
- 3. If any new or increased charges for use of telephone or other communication lines or services or if any new or increased taxes, false alarm assessments, or license fees shall be hereafter charged, levied against or imposed upon *EPS* or its business or any phase thereof, the effect of which shall be to increase to *EPS* the cost of performing this agreement, the calculated amount of the monthly installments payable by Subscriber shall be proportionately increased and as so increase shall be promptly paid by the Subscriber. An operating cost increase under this subparagraph is not an increase in the annual charge for services under Paragraph B(2) and no right of refusal or termination is granted to Subscriber for an operation cost increase assessed under this subparagraph.
- 4. In the event *EPS*'s representative is sent to the Subscriber's premise in response to a service call or signal caused by the Subscriber improperly following operating instructions or failing to close or properly secure a window, door or other protected point, there shall be a service charge to the Subscriber, which subscriber agrees to pay upon billing by *EPS*.

#### C. TERM:

- 1. Except as otherwise herein provided, this agreement shall remain in full force and effect for a period of Three (3) years from the date System becomes operative, or the date of this contract, whichever is later. After the Three (3) years, this Agreement shall automatically renew on a year to year basis unless terminated by either party by written notice to the other party postmarked thirty (30) day prior to the expiration date or any extension thereof. In the event of termination prior to the end of the contract term, the Subscriber agrees to pay, in addition to any charges for services rendered prior to termination date, 75% of the service charge remaining to be paid for the unexpired term of the agreement as liquidated damages (but not as penalty).
- 2. Title to the equipment is to remain with EPS until the full purchase price is paid. Failure to pay the purchase price of the installed equipment when due shall give EPS the right, without obligation to redecorate or repair the premises or any other liability, to repossess that equipment with or without notice, and to avail itself of any legal remedy.

#### D. LIMIT OF LIABILITY

IT IS UNDERSTOOD AND AGREED BY THE PARTIES HERETO THAT *EPS* IS NOT AN INSURER AND THAT INSURANCE, IF ANY, COVERING PERSONAL INJURY AND PROPERTY LOSS OR DAMAGE ON SUBSCRIBER'S PREMISES SHALL BE OBTAINED BY THE SUBSCRIBER: THAT *EPS* IS BEING PAID FOR THE INSTALLATION, MONITORING AND SERVICE OF SYSTEM DESIGNED TO REDUCE CERTAIN RISKS OF LOSS AND THAT THE AMOUNTS BEING CHARGED BY *EPS* ARE NOT SUFFICIENT TO GUARANTEE THAT NO LOSS WILL OCCUR; THAT *EPS* IS

NEGLIGENT PERFORMANCE BY EPS OR BY ANY SUBCONTRACTORS USED BY EPS OR FAILURE TO PERFORM ANY OF ITS OBLIGATIONS, SINCE IT IS IMPRACTICAL AND EXTREMELY DIFFICULT TO FIX ACTUAL DAMAGES WHICH MAY ARISE DUE TO THE FAULTY OPERATION OF THE SYSTEM OR FAILURE OF SERVICES PROVIDED, IF, NOT WITHSTANDING THE ABOVE PROVISIONS, THERE SHOULD ARISE ANY LIABILITY ON THE PART OF *EPS*, SUCH LIABILITY SHALL BE LIMITED TO AN AMOUNT EQUAL TO ONE-HALF (1/2) THE ANNUAL SERVICE CHARGE PROVIDED HEREIN OR \$250.00, WHICHEVER IS THE LESSER, AND THIS LIABILITY SHALL BE EXCLUSIVE. IN THE EVENT THE SUBSCRIBER WISHES THE COMPANY TO ASSUME A GREATER OR HIGHER LIMITATION OF LIABILITY, THE SUBSCRIBER MAY, AS A MATTER OF RIGHT, OBTAIN FROM THE COMPANY A HIGHER LIMIT BY PAYING AN ADDITIONAL AMOUNT PROPORTIONED TO THE INCREASE IN DAMAGES, BUT SUCH ADDITIONAL OBLIGATION SHALL IN NO WAY BE INTERPRETED TO HOLD THE COMPANY AS AN INSURER. IF THE SYSTEM INCLUDES COMPONENTS MANUFACTURED BY HONEYWELL INTERNATIONAL INC ("HONEYWELL") THE SAME LIMITATION OF LIABILITY SHALL EXIST FOR ANY CLAIM MADE BY SUBSCRIBER AGAINST HONEYWELL.

SUBSCRIBER AGREES THAT ANY LEGAL ACTION FOR A CLAIM WHICH IT MAY HAVE AGAINST EPS ARISING OUT OF EPS'S PERFORMANCE OF THIS CONTRACT MUST BE FILED WITHIN ONE YEAR OF THE DATE THAT THE CLAIM AROSE (WHICH IN THE CASE OF A LOSS SUFFERED BY CUSTOMER SHALL BE THE DATE THE LOSS OCCURRED) AND FURTHER AGREES THAT A CLAIM PERIOD OF ONE YEAR IS REASONABLE.

### **E. LIMITED WARRANTY:**

EPS DOES NOT MAKE ANY REPRESENTATION OR WARRANTY, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS, THAT THE SYSTEM OR SERVICE SUPPLIED MAY NOT BE COMPROMISED OR THAT THE SYSTEM OR SERVICES WILL IN ALL CASES PROVIDE THE PROTECTION FOR WHICH IT IS INTENDED. THERE ARE NO IMPLIED WARRANTIES WHATSOEVER.

### F. SUBSCRIBER'S INDEMNIFICATION

WHEN SUBSCRIBER IN THE ORDINARY COURSE OF BUSINESS HAS THE PROPERTY OF OTHERS IN HIS CUSTODY, OR THE SYSTEM EXTENDS TO PROTECT THE PROPERTY OF OTHERS, OR THE SYSTEM IS MONITORED BY OTHERS, SUBSCRIBER AGREES TO AND SHALL INDEMNIFY, DEFEND AND HOLD HARMLESS EPS, ITS EMPLOYEES AND AGENTS FOR AND AGAINST ALL CLAIMS BROUGHT BY PARTIES OTHER THAN THE PARTIES TO THIS AGREEMENT. THIS PROVISION SHALL APPLY TO ALL CLAIMS REGARDLESS OF CAUSE INCLUDING EPS'S PERFORMANCE OR FAILURE TO PERFORM AND INCLUDING DEFECTS IN PRODUCTS, DESIGN, INSTALLATION, SERVICE, OPERATION AND NON-OPERATION OF THE SYSTEM WHETHER BASED UPON NEGLIGENCE, ACTIVE OR PASSIVE, EXPRESS OR IMPLIED CONTRACT OR WARRANTY, CONTRIBUTION OR INDEMNIFICATION, OR STRICT OR PRODUCT LIABILITY ON THE PART OF EPS, ITS EMPLOYEES OR AGENTS, BUT THIS PROVISION SHALL NOT APPLY TO CLAIMS FOR LOSS OR DAMAGE SOLELY AND DIRECTLY CAUSED BY AN EMPLOYEE OF EPS WHILE ON SUBSCRIBER'S PREMISES.

### **G. SUBCONTRACTORS:**

SUBSCRIBER ACKNOWLEDGES THAT THE PROVISIONS OF THIS AGREEMENT, AND PARTICULARLY THOSE PARAGRAPHS RELATING TO DISCLAIMER OF WARRANTY, LIMIT OF LIABILITY AND THIRD PARTY INDEMNIFICATION INURE TO THE BENEFIT OF AND ARE APPLICABLE TO ANY SUBCONTRACTORS ENGAGED BY *EPS* TO PROVIDE MONITORING, INSTALLATION OR SERVICE OF THE SYSTEM PROVIDED HEREIN, AND BIND SUBSCRIBER TO SAID SUBCONTRACTOR WITH THE SAME FORCE AND EFFECT AS THEY BIND SUBSCRIBER TO *EPS*. SUBSCRIBER AGREES TO INDEMNIFY, DEFEND AND HOLD HARMLESS *EPS* AGAINST CLAIMS BY ANY ORGANIZATION ENGAGED TO MONITOR SUBSCRIBER'S SYSTEM OR TO WHICH A SIGNAL MAY BE TRANSMITTED.

### H. APPROVAL:

This Agreement shall not be effective until executed in writing by an authorized representative of EPS. Further, this Agreement supersedes all previous Agreements and any Riders thereto, between the parties.

### I. ENTIRE AGREEMENT

The Agreement of the parties is expressed hereinabove and in the Terms and Conditions on the reverse side and no verbal understandings or agreement shall alter, change or modify the terms and provisions of this Agreement. It is understood and agreed by and between the parties hereto, that if there is any conflict between this Agreement and Subscriber's purchase order, or any other document, this agreement will govern, whether such purchase order or other document is prior or subsequent to this Agreement.

SUBSCRIBER ACKNOWLEDGES THAT THE LIABILITY OF *EPS* IS LIMITED AS SET FORTH IN PARAGRAPHS D, E, F AND G, AND ACCEPTS THE LIMIT SET FORTH THEREIN. SUBSCRIBER ACCEPTS ALL THE PROVISIONS OF THIS AGREEMENT AND AGREES THAT THERE HAS BEEN NO BELIANCE PLACED ON ANY PROVISION NOT APPEARING HEREIN.

### **TERMS AND CONDITIONS**

- 1. SUBSCRIBER'S AUTHORIZATION Subscriber hereby authorizes and empowers EPS, its agents or assigns as follows:
- A. To install said System as described in the Schedule of Protection at said location
- B. To enter the premises for the purpose of inspecting, testing and repairing said System
- C. To enter the premises in answer to a signal as representative and agent of Subscriber

### 2. SERVICE AGREEMENT:

A. Service for the equipment supplied under this Agreement will be provided by EPS if on the reverse side of this Agreement, Service Agreement is checked. All ordinary expenses of service and repairs shall be borne by EPS but if rendered necessary by alterations or repairs to the premises, such expenses shall be borne by Subscriber. If service agreement is not included, EPS will, if requested, provide the Subscriber with repair and parts replacement for the equipment at EPS's prevailing prices and terms at the time.

- B. Should any part of the system be damaged by fire, water or extraneous causes, repairs shall be paid for by Subscriber.
- C. If Subscriber's insurer, or any inspection bureau having jurisdiction, or by Subscriber's own act, shall require or make necessary any changes to the System as originally installed, Subscriber agrees to pay for the cost of such changes.
- D. It is understood and agreed that EPS's obligations relates to the service of the specified System(s), and that EPS is in no way obligated to maintain, repair, service, operate or assure the operation of the property, system or any devices of the Subscriber or of others to which EPS's Systems are attached.
- E. The Subscriber agrees that any person or persons, unauthorized by EPS will not be permitted to after, remove or tamper with Equipment mentioned herein, and will safeguard said equipment against loss and damage during the term of this agreement. The Subscriber shall not permit any device, contrivance or apparatus to be attached to the lines, wires, instruments or equipment of such System, except by the authorized agents of EPS without the written permission of EPS.
- F. Service will be furnished by EPS during its normal working hours, Monday through Friday, except holidays. EPS shall have full and free access to the equipment to perform service thereon. EPS shall not be responsible for failure to render service due to causes beyond its control. Service rendered outside the normal working hours for EPS are not within the scope of the Service Agreement unless specifically agreed to between EPS and the Subscriber and so noted on this document.
- **G.** Subscriber shall carefully and properly set the system at closing of the premises. Subscriber shall carefully and properly test the equipment designated on the schedule of protection, prior to each closed period and shall immediately report to EPS any claimed inadequacy in or failure of the System. EPS shall make such repairs as soon after receipt of notice as is reasonably possible.
- H. If the System includes a sprinkler system, EPS shall be responsible only for the service of EPS's equipment, and only for making the appropriate response to an alarm signal, if received by EPS. Subscriber is solely responsible for maintenance of the sprinkler system, including adequate heat, so it will at all times be in good working order. If pressure pumps are needed for proper operation of sprinkler supervisory and water flow alarms, due to fluctuation in the water pressure, such pressure pumps shall be provided by the Subscriber at Subscriber's expense.
- I. Communication devices no longer supported by communication pathways, obsolete components and components exceeding manufacturer's useful life are not included in service and will be repaired or replaced at Subscriber's expense.

### 3. MONITORING:

- A. Signal receiving and notification service shall be provided by EPS if on the reverse side of this Agreement the Monitoring option is checked. The Subscriber agrees to furnish EPS a list of the names of all persons with whom EPS is authorized by Subscriber to communicate regarding the System and any signals received if EPS provides monitoring services.
- B. Subscriber also understands EPS does not receive signals when the transmission mode is or becomes non-operational and that signals from the digital communicator cannot be received if the transmission mode is cut, interfered with or otherwise damaged. Subscriber acknowledges that a cellular communication back-up device is available at an extra expense.
- C. In the event BURGLARY PROTECTION SERVICE is furnished under this Agreement, upon receipt of a burglar alarm signal from Subscriber's premises, EPS, at its sole discretion, shall attempt to First contact a designated representative at the premise. If EPS has not contacted a designated representative, then EPS may attempt to contact the first designated representative on the contact list provided by Subscriber to EPS. If EPS is unable to reach a designated representative of Subscriber, then EPS shall make every reasonable effort to transmit the alarm promptly to the headquarters of the municipal police department, unless there is just cause to assume that an emergency condition does not exist.
- D. In the event FIRE ALARM SERVICE is furnished under this Agreement, EPS shall make every reasonable effort to transmit to the municipal fire department all fire alarm signals received at this Central Station from the Fire Alarm System.
- E. In the event MEDICAL ALERT OR HOLD-UP/PANIC ALARM SERVICE is furnished under this Agreement, EPS shall, on receipt of medical afert or hold-up/panic alarm signal from the Subscribers premises, make every reasonable effort to transmit the alarm promptly to the headquarters of the municipal police department or designated emergency service.
- F. In the event a SUPERVISORY OR TROUBLE SIGNAL registers at EPSs Central Station, EPS shall make every reasonable effort to notify the designated representative of Subscriber.
- G. OPENING & CLOSING SUPERVISION shall be provided by EPS if, on the reverse side of this Agreement, opening and dosing supervision is checked.
- H. If ALARM RESPONSE SERVICE is available and is checked in this Agreement, on receipt of an alarm signal from Subscriber's premises, EPS will make a reasonable effort to send its representative, who will, only if Subscriber has provided a key in an EPS approved knox box located on premises, enter and make search of Subscriber's premises and is hereby authorized, as the agent of Subscriber, to cause the arrest of any person or persons found on the premises without authority to enter, and to hold or cause to be held, him or them, until released by Subscriber or Subscriber's authorized representative. In the event of interruption to the burglar alarm service, the services of EPS shall cease upon visual inspection of the protected premises from the inside and making of necessary emergency repairs to the burglar alarm system, where keys have been furnished in an EPS approved knox box. Where a knox box has not been furnished, services of EPS shall cease upon visual inspection of the protected premises from the outside.

### 4. CANCELLATION:

A. This Agreement may be terminated at the option of EPS at any time in the event that EPSs Central Station is destroyed or so substantially damaged by fire or other catastrophe that it is impractical to continue service, or in the event that EPS is unable either to secure or retain the connections or privileges necessary for the transmission of signals by means of communication between the Subscriber's premises and EPSs Central Station or agency and EPS shall not be liable for any damages or subject to any penalty as a result of such termination. In the event of

such termination, EPS will refund to the Subscriber any advance payments made for service to be supplied subsequent to the date of such termination.

- **B.** It is understood and agreed that this Agreement may be terminated by EPS in the event that the Subscriber fails to follow any recommendations EPS may make for the repair or the replacement of defective parts of their system not covered under the Service Agreement or in the event that the Subscriber's failure to follow the operating instructions provided results in an undue number of false alarms or if the premises in which the system is installed are so modified or altered after installation as to render continuation of service impractical.
- C. In the event the Subscriber defaults in the performance of this Agreement in any manner whatsoever, including but not limited to, failure to make payments as specified or preventing EPS from performing its obligations under this agreement in any manner, the balance of all monies due for the unexpired term of this Agreement shall become due and payable to EPS immediately, and Subscriber acknowledges it is obligated to pay 75% of such amount in lump sum to EPS as liquidated damages.

### 5. INSTALLATION:

- A. EPS assumes no liability for delay in installation of the System, or interruption of service due to strikes, riots, floods, fires, acts of God or any cause beyond the control of EP5 including interruption in telephone services. EPS will not be required to supply service to the Subscriber while interruption of service due to any such cause shall continue.
- **B.** Any installation charge quoted in this agreement is based on EPS performing the installation with its own personnel, or EPSs subcontractors. If for any reason this installation must be performed by outside Contractors, said installation charge shall be subject to revision.
- C. Subscriber hereby authorizes EPS to make installations during regular working hours. Any variation from or alteration of the installation herein specified must be requested in writing by Subscriber and shall be paid for by Subscriber.
- D. Subscriber shall supply or provide the necessary energy and power required to operate said System(s) at no expense to EPS. In the event of a power failure or other interruption at Subscribers premises, Subscriber shall notify EPS immediately.
- E. Telephone Service. Subscriber shall supply, at no charge to EPS, telephone hook ups, Internet access, and IP addresses as deemed necessary by EPS, in its sole discretion, AND TO NOTIFY EPS OF ANY CHANGE IN SUCH SERVICE.
- F. Wire mold or conduit for any wiring, plenum wire, trenching for buried conduit or wiring located outside the building is not included in the agreement, unless specifically included in our proposal. If any of the preceding is required, Subscriber will agree to provide such at Subscriber's expense.
- G. Subscriber acknowledges that EPS has no way of knowing of the existence of hidden pipes, wires or other obstructions within walls, and it is Subscriber's obligation to make EPS aware of such conditions, failing which EPS shall have no responsibility whatsoever for damage that may be caused.
- H. Customer acknowledges and agrees permit fees will be billed direct to customer as a passthrough cost on the final invoice.
- 6. WAIVER OF JURY TRIAL EPS AND SUBSCRIBER, AFTER CONSULTING OR HAVING HAD THE OPPORTUNITY TO CONSULT WITH COUNSEL, KNOWINGLY, VOLUNTARILY AND INTENTIONALLY WAIVE ANY RIGHT TO A TRIAL BY JURY IN ANY LITIGATION BASED UPON OR ARISING OUT OF THIS AGREEMENT OR ANY CONDUCT, DEALING, STATEMENTS (WHETHER ORAL OR WRITTEN) OR ACTIONS OF ANY OF THEM. NEITHER EPS NOR SUBSCRIBER SHALL SEEK TO CONSOLIDATE, BY COUNTERCLAIM OR OTHERWISE, ANY SUCH ACTION IN WHICH A JURY TRIAL HAS BEEN WAIVED WITH ANY OTHER ACTION IN WHICH A JURY TRIAL CANNOT BE OR HAS NOT BEEN WAIVED. THESE PROVISIONS SHALL NOT BE DEEMED TO HAVE BEEN MODIFIED IN ANY RESPECT OR RELINQUISHED BY ANY PARTY HERETO EXCEPT BY A WRITTEN INSTRUMENT EXECUTED BY SUCH PARTY.
- 7. ATTORNEY FEES If Subscriber defaults under this Agreement, then in addition to payment of liquidated damages to EPS, Subscriber also agrees to pay on demand all reasonable attorney fees incurred by EPS in protecting and enforcing the rights of and obligations to EPS under this Agreement, including its right to take possession of its equipment from Subscriber, or Subscriber's landlord, or any receiver or trustee in bankruptcy appointed for Subscriber.

### INTERNET/CELLULAR MONITORING ADDENDUM

At your choice, the monitoring service being provided to you by EPS will use the public Internet and/or the Cellular network, as the means of communication of signals from your premises to our Central Station.

The provision of public Internet service to your premises is your responsibility. You are encouraged to select an Internet Service Provider (ISP) that provides adequate standby power and 24-hour support service. Where the ISP requires that your connection be verified, authenticated or "togged on," it will be your responsibility to provide the necessary software and/or equipment to accomplish this requirement.

EPS will supply and install an Internet Signal Transmitter (IST) connected to your security system control unit. It will be your responsibility to provide, within 5 feet of your security control unit, a suitable RJ-45 Ethernet connection into which we will plug our 1ST.

It will be your responsibility to provide standby electrical power to your broadband modem and any other devices such as routers, hubs or switches that may affect the Internet communications with a recommended standby duration of 24 hours, but in all cases not less than 15 minutes. You are on notice that communications will fail if the power for your modem, routers, hubs, switches, etc. is interrupted.

You are advised that a failure in the communication facilities may occur for any number of reasons including, but not limited, to: a) intentional cutting or severing of communication cables entering your premises; b) loss of commercial electrical power and a subsequent failure or depletion of standby power; c) a failure of your modem, hub, router, switch or other equipment in the Internet path within your premises; d) a failure of the 1ST; e) a failure or malfunction of an ISP or its facilities; f) a failure in the cellular network; g) a failure in the AlarmNet network or equipment; h) any other failure beyond the control of EPS.

When our Central Station is alerted of a failure in the communication facilities, it is not our current policy to notify you, since under current technology there are frequent interruptions which occur.

Upon receiving notification of a failure in the communication facilities, it will be your responsibility to verify that the public Internet service to your premises is functioning correctly. Once you have determined that your public Internet connection is working properly, it will be your responsibility to telephone our Central Station and determine if communications have been restored.

If the services of an EPS technician are required, a service charge will apply if no fault is found in the security system or the 1ST but a problem is observed in your public Internet connection or any equipment associated with the public Internet connection, or as a result of a failure of the standby power for your equipment.

It is agreed and understood that EPS has no control over the provision of public Internet service to you and/or your premises and, as such, EPS has no control over the reliability of the service nor does EPS have any control over the provision of primary or standby power for the Internet modern, hubs, routers, switches or other equipment on your premises. If, in the sole opinion of EPS, there are excessive failures in the communication facilities resulting in additional and unusual expenses incurred in the reporting and clearing of signals, EPS may, at its sole discretion, levy additional charges to you as our compensation for the additional and unusual costs.

### **CELLULAR PROTECTION PLAN**

A. If Cellular Protection Plan is checked on the front of the Agreement, all ordinary expenses of service, repair and upgrades (when necessary) of the Cellular Equipment (Equipment) listed on this Agreement shall be borne by EPS, but if rendered necessary by alterations or repairs to the premises where the Equipment is located, such expenses shall be borne by Subscriber.

- B. Should any part of the Equipment be damaged by fire, water or other casualty repairs shall be paid for by Subscriber.

### B. PAYMENTS:

1. The subscriber agrees to pay *EPS*, its agents or assigns, the sum of \$4,200.00 plus tax. One half to be paid upon signing of this agreement and one half to be paid upon completion of installation of said System.

The Subscriber agrees to pay EPS, its agents or assigns, in addition, for the services provided if checked above, the sum of \$30.00, in addition to \$125.00 per month and is billed per quarterthat is payable in advance on the first day of each quarter during the term hereof.

### Tax Exempt (If selected, Plus Tax above is void)

- 2. EPS shall have the right to increase the annual service charge provided for herein at any time after the expiration of one (1) year from the date such System is operative under this agreement upon giving the Subscriber written notice twenty-five (25) days in advance of the effective date of such increase. Subscriber shall notify EPS prior to the effective date of the increase if the Subscriber is unwilling to pay any such increased charge. If Subscriber timely provides such notice to EPS, EPS has the option of rescinding the increase and continuing with the contract, or terminating the contract. Any advance payments made for service to be supplied subsequent to the date of such termination shall be refunded to the Subscriber.
- 3. NEGLIGENT PERFORMANCE BY EPS OR BY ANY SUBCONTRACTORS USED BY EPS OR FAILURE TO PERFORM ANY OF ITS OBLIGATIONS, SINCE IT IS IMPRACTICAL AND EXTREMELY DIFFICULT TO FIX ACTUAL DAMAGES WHICH MAY ARISE DUE TO THE FAULTY OPERATION OF THE SYSTEM OR FAILURE OF SERVICES PROVIDED, IF, NOT WITHSTANDING THE ABOVE PROVISIONS, THERE SHOULD ARISE ANY LIABILITY ON THE PART OF EPS, SUCH LIABILITY SHALL BE LIMITED TO AN AMOUNT EQUAL TO ONE-HALF (1/2) THE ANNUAL SERVICE CHARGE PROVIDED HEREIN OR \$250,00, WHICHEVER IS THE LESSER, AND THIS LIABILITY SHALL BE EXCLUSIVE. - 1. SUBSCRIBER'S AUTHORIZATION Subscriber hereby authorizes and empowers EPS, its agents or assigns as follows:
- A. To install said System as described in the Schedule of Protection at said location
- B. To enter the premises for the purpose of inspecting, testing and repairing said System
- C. To enter the premises in answer to a signal as representative and agent of Subscriber

### 2. SERVICE AGREEMENT:

A. Service for the equipment supplied under this Agreement will be provided by EPS if on the reverse side of this Agreement, Service Agreement is checked. All ordinary expenses of service and repairs shall be borne by EPS but if rendered necessary by alterations or repairs to the premises, such expenses shall be borne by Subscriber. If service agreement is not included, EPS will, if requested, provide the Subscriber with repair and parts replacement for the equipment at EPS's prevailing prices and terms at the time.

- B. Should any part of the system be damaged by fire, water or extraneous causes, repairs shall be paid for by Subscriber.
- C. If Subscriber's insurer, or any inspection bureau having jurisdiction, or by Subscriber's own act, shall require or make necessary any changes to the System as originally installed, Subscriber agrees to pay for the cost of such changes.
- **D.** It is understood and agreed that EPS's obligations relates to the service of the specified System(s), and that EPS is in no way obligated to maintain, repair, service, operate or assure the operation of the property, system or any devices of the Subscriber or of others to which EPS's Systems are attached.
- E. The Subscriber agrees that any person or persons, unauthorized by EPS will not be permitted to alter, remove or tamper with Equipment mentioned herein, and will safeguard said equipment against loss and damage during the term of this agreement. The Subscriber shall not permit any device, contrivance or apparatus to be attached to the lines, wires, instruments or equipment of such System, except by the authorized agents of EPS without the written permission of EPS.
- F. Service will be furnished by EPS during its normal working hours, Monday through Friday, except holidays. EPS shall have full and free access to the equipment to perform service thereon. EPS shall not be responsible for failure to render service due to causes beyond its control. Service rendered outside the normal working hours for EPS are not within the scope of the Service Agreement unless specifically agreed to between EPS and the Subscriber and so noted on this document.
- G. Subscriber shall carefully and properly set the system at closing of the premises. Subscriber shall carefully and properly test the equipment designated on the schedule of protection, prior to each closed period and shall immediately report to EPS any claimed inadequacy in or failure of the System. EPS shall make such repairs as soon after receipt of notice as is reasonably possible.
- H. If the System includes a sprinkler system, EPS shall be responsible only for the service of EPS's equipment, and only for making the appropriate response to an alarm signal, if received by EPS. Subscriber is solely responsible for maintenance of the sprinkler system, including adequate heat, so it will at all times be in good working order. If pressure pumps are needed for proper operation of sprinkler supervisory and water flow alarms, due to fluctuation in the water pressure, such pressure pumps shall be provided by the Subscriber's expense.
- I. Communication devices no longer supported by communication pathways, obsolete components and components exceeding manufacturer's useful life are not included in service and will be repaired or replaced at Subscriber's expense.

### 3. MONITORING:

- A. Signal receiving and notification service shall be provided by EPS if on the reverse side of this Agreement the Monitoring option is checked. The Subscriber agrees to furnish EPS a list of the names of all persons with whom EPS is authorized by Subscriber to communicate regarding the System and any signals received if EPS provides monitoring services.
- B. Subscriber also understands EPS does not receive signals when the transmission mode is or becomes non-operational and that signals from the digital communicator cannot be received if the transmission mode is cut, interfered with or otherwise damaged. Subscriber acknowledges that a cellular communication back-up device is available at an extra expense.
- C. In the event BURGLARY PROTECTION SERVICE is furnished under this Agreement, upon receipt of a burglar alarm signal from Subscriber's premises, EPS, at its sole discretion, shall attempt to First contact a designated representative at the premise. If EPS has not contacted a designated representative, then EPS may attempt to contact the first designated representative on the contact list provided by Subscriber to EPS. If EPS is unable to reach a designated representative of Subscriber, then EPS shall make every reasonable effort to transmit the alarm promptly to the headquarters of the municipal police department, unless there is just cause to assume that an emergency condition does not exist.
- D. In the event FIRE ALARM SERVICE is furnished under this Agreement, EPS shall make every reasonable effort to transmit to the municipal fire department all fire alarm signals received at this Central Station from the Fire Alarm System.
- E. In the event MEDICAL ALERT OR HOLD-UP/PANIC ALARM SERVICE is furnished under this Agreement, EPS shall, on receipt of medical alert or hold-up/panic alarm signal from the Subscribers premises, make every reasonable effort to transmit the alarm promptly to the headquarters of the municipal police department or designated emergency service.
- F. In the event a SUPERVISORY OR TROUBLE SIGNAL registers at EPSs Central Station, EPS shall make every reasonable effort to notify the designated representative of Subscriber.
- G. OPENING & CLOSING SUPERVISION shall be provided by EPS if, on the reverse side of this Agreement, opening and dosing supervision is checked.
- H. If ALARM RESPONSE SERVICE is available and is checked in this Agreement, on receipt of an alarm signal from Subscriber's premises, EPS will make a reasonable effort to send its representative, who will, only if Subscriber has provided a key in an EPS approved knox box located on premises, enter and make search of Subscriber's premises and is hereby authorized, as the agent of Subscriber, to cause the arrest of any person or persons found on the premises without authority to enter, and to hold or cause to be held, him or them, until released by Subscriber or Subscriber's authorized representative. In the event of interruption to the burglar alarm service, the services of EPS shall cease upon visual inspection of the protected premises from the inside and making of necessary emergency repairs to the burglar alarm system, where keys have been furnished in an EPS approved knox box. Where a knox box has not been furnished, services of EPS shall cease upon visual inspection of the protected premises from the outside.

### 4. CANCELLATION:

A. This Agreement may be terminated at the option of EPS at any time in the event that EPSs Central Station is destroyed or so substantially damaged by fire or other catastrophe that it is impractical to continue service, or in the event that EPS is unable either to secure or retain the connections or privileges necessary for the transmission of signals by means of communication between the Subscriber's premises and EPSs Central Station or agency and EPS shall not be flable for any damages or subject to any penalty as a result of such termination. such termination, EPS will refund to the Subscriber any advance payments made for service to be supplied subsequent to the date of such termination.

B. WAIVER OF JURY TRIAL EPS AND SUBSCRIBER, AFTER CONSULTING OR HAVING HAD THE OPPORTUNITY TO CONSULT WITH COUNSEL, KNOWINGLY, VOLUNTARILY AND INTENTIONALLY WAIVE ANY RIGHT TO A TRIAL BY JURY IN ANY LITIGATION BASED UPON OR ARISING OUT OF THIS AGREEMENT OR ANY CONDUCT, DEALING, STATEMENTS (WHETHER ORAL OR WRITTEN) OR ACTIONS OF ANY OF THEM. NEITHER EPS NOR SUBSCRIBER SHALL SEEK TO CONSOLIDATE, BY COUNTERCLAIM OR OTHERWISE, ANY SUCH ACTION IN WHICH A JURY TRIAL HAS BEEN WAIVED WITH ANY OTHER ACTION IN WHICH A JURY TRIAL CANNOT BE OR HAS NOT BEEN WAIVED. At your choice, the monitoring service being provided to you by EPS will use the public Internet and/or the Cellular network, as the means of communication of signals from your premises to our Central Station.

The provision of public Internet service to your premises is your responsibility. You are encouraged to select an Internet Service Provider (ISP) that provides adequate standby power and 24-hour support service. Where the ISP requires that your connection be verified, authenticated or "logged on," it will be your responsibility to provide the necessary software and/or equipment to accomplish this requirement.

EPS will supply and install an Internet Signal Transmitter (IST) connected to your security system control unit. It will be your responsibility to provide, within 5 feet of your security control unit, a suitable RJ-45 Ethernet connection into which we will plug our 1ST.

It will be your responsibility to provide standby electrical power to your broadband modem and any other devices such as routers, hubs or switches that may affect the Internet communications with a recommended standby duration of 24 hours, but in all cases not less than 15 minutes. You are on notice that communications will fail if the power for your modem, routers, hubs, switches, etc. is interrupted.

You are advised that a failure in the communication facilities may occur for any number of reasons including, but not limited, to: a) intentional cutting or severing of communication cables entering your premises; b) loss of commercial electrical power and a subsequent failure or depletion of standby power; c) a failure of your modem, hub, router, switch or other equipment in the Internet path within your premises; d) a failure of the 1ST; e) a failure or malfunction of an ISP or its facilities; f) a failure in the cellular network; g) a failure in the AlarmNet network or equipment; h) any other failure beyond the control of EPS.

When our Central Station is alerted of a failure in the communication facilities, it is not our current policy to notify you, since under current technology there are frequent interruptions which occur.

Upon receiving notification of a failure in the communication facilities, it will be your responsibility to verify that the public Internet service to your premises is functioning correctly. Once you have determined that your public Internet connection is working properly, it will be your responsibility to telephone our Central Station and determine if communications have been restored.

SUBJECT: 2023 WAGE SCALE & LIST OF AUTHORIZED POSITIONS/RATES

### **BACKGROUND**

Basic to salary administration is the maintenance of a structure to provide a hierarchy of progressively higher pay grades, with pay ranges, along with a system for placing individual jobs into that structure. A Township Wage Scale, grades 1-12, is used for all regularly recurring Administrative/Professional staff jobs. In addition, the Township will set a separate pay structure for positions not listed on the wage scale and Township Boards/Committees. The pay structure is subject to annual review and adjustment. The organizational structure is approved through the annual budget process.

The Fair Labor Standards Act (FLSA) provides guidelines for pay for all employees not specifically exempted. Generally, professionals, executives, and administrators who regularly exercise independent judgement and discretionary authority concerning the daily business of the organization may be exempted by the employer if other conditions are met. For persons not in exempted positions, the act provides for a minimum hourly pay rate, the maintenance of detailed time worked, and overtime pay at a premium rate equal to one and one-half the regular rate for work in excess of 40 hours each seven-day pay period.

### **POLICY FOCUS**

During the 2021 Audit, the Auditors provided a verbal comment stating that on an annual basis, the Township Board should review and approve the wage scale for all employees. The annual budget approves the organizational structure which consolidates approved positions by department but does not delineate each position by title and rate. It is the recommendation of the Auditors that, on an annual basis, the Township Board approve the wages rates for all Township positions. The wages rates should be classified by a scale and/or individually

listed by title and rate. The exception to the annual approval process is the Township's agreement with the KTPOA which sets all rates and terms of employment in their agreement.

### **FISCAL IMPACT**

The 2023 wages rates have been, where applicable, increased by a 5% Cost of Living Adjustment.

### **RECOMMENDATION**

The Township Board state a motion to approve the 2023 Wage Scale and all other rates as set forth in the attached document.

The following is a synopsis of the tentative agreement between the Township of Kalamazoo and the KTPOA, which represents the majority of the sworn officers within the police department.

<u>Length of Agreement</u>: The current agreement expires on December 31, 2022. The proposed agreement would be in effect starting in 2023 and conclude after four (4) years at the end of 2026.

### Salary:

### *OFFICERS*:

For 2023, employees at Police Officer 1 (P.O. 1) to Police Officer (P.O. 6) classifications will receive a six percent (6%) raise.

For 2024, employees at Police Officer 1 (P.O. 1) to Police Officer (P.O. 6) classifications will receive a five percent (5%) raise.

For 2025, employees at Police Officer 1 (P.O. 1) to Police Officer (P.O. 6) classifications will receive a four percent (4%) raise.

For 2026, employees at Police Officer 1 (P.O. 1) to Police Officer (P.O. 6) classifications will receive a three percent (3%) raise.

### DETECTIVES:

Detective pay rate will be calculated at P.O. 6 rate plus 4% for each year of the agreement.

### SERGEANTS:

Sergeant (Sgt.) pay rate will be calculated at P.O. 6 rate plus the corresponding percentage based upon their classification:

- Sgt. 1 = 6%
- Sgt. 2 = 9%
- Sgt. 3 = 12%

<u>Vacation pay-out option:</u> This voluntary option allows employees who carry over fifty percent (50%) of their allowed accruable vacation time to "cash out" 40 hours of time at the beginning of December each year.

**MERS:** For the term of this agreement, the Township will pay the MERS pension obligation in January in an effort to be proactive in fiduciary responsibility.

<u>Language Changes:</u> Both the KTPOA and the Township revised numerous language changes throughout the agreement.
