POLICE BLOTTER

May 13, 2024

- 0025 hrs Officers initiated a traffic stop for violations near W. Dorothy/S. Dixie. The driver, **Matthew R. Miller (W/M/36)** was arrested on warrants through Clark County S.O. for FTA-DUS and on an indictment for Possession of Drugs (F). **24-022436**
- 0223 hrs Officers made a stop at Valley Thrift on Woodman. The driver, **Christine P. Neff (W/F/43)** was arrested on an active Dayton warrant, original charge Public Indecency. **24-022447**
- 0340 hrs Officers stopped a vehicle at 1137 E. David. The driver refused to identify himself and tried to walk into the house. **Brandon G. Dryer (W/M/28)** was arrested for Failure to Identify and also charged with Resisting Arrest because he refused to be handcuffed and, once finally handcuffed, refused to get into the cruiser. **24-022455**
- 0950 hrs Officers met a Fairborn PD unit for a field transfer. Upon arrival **Christopher S. Carver (W/M/28)** was taken into custody for a criminal damaging warrant. Carver was booked into the KPD jail without incident. **23-011986**
- 1349 hrs Officers initiated a traffic stop at 1625 Calvary Dr. for multiple violations. The driver **Jonathan D. Hause (W/M/33)** initially lied about his identity. Upon confirming House's identity, it was learned that he had two warrants through Miamisburg PD for DUS. Upon a search of the vehicle due to a positive alert by K9 Thor, suspected cocaine and paraphernalia were located inside. **Samantha L. Smith (W/F/36)** was arrested for Possession of Drugs, Failure to Comply, Resisting Arrest and Possession of Drug Paraphernalia. **24-022701**
- 1524 hrs Officers responded to Meijer, 4075 Wilmington Pike, for a juvenile shoplifter detained in the LP office. The **14 year old male** had attempted to steal alcohol. He was issued a summons for theft and released to his mother. **24-022701**
