## KETTERING CITY COUNCIL REGULAR MEETING MINUTES May 14, 2024

The Council of the City of Kettering, Ohio, met in regular session on Tuesday, May 14, 2024, at 7:30 p.m. in Council Chambers at the Kettering Government Center South Building, 3600 Shroyer Road. Mayor Lehner presided and the Acting Clerk of Council, Jenifer Baker, recorded. This meeting was telecast live on the cable access channel and streamed live at mycc.net.
