Mr. Lou York, 4001 Glenheath Drive and have lived there for 46 years. He remarked that his first concern is does the City of Kettering have a noise ordinance and how is it enforced. Chief Protsman responded that the noise ordinance is across property lines is that what you are referring to? Mr. York responded that he is talking about street noise. Chief Protsman responded that street noise is difficult to enforce and we have no specific ordinance but for loud noise so if the police department receives complaints they will put officers in those areas to try and monitor that. Chief Protsman noted that they do have a Supervisor who is assigned to traffic issues that the police department receives and then the Supervisor gives those concerns to certain officers who are then put in those areas during certain times to do enforcement action and they do a report on what action was taken and if we need to address any issues found.

Mr. York's other concern is traffic lights and the countdown signals not working properly specifically at Marshall and Wilmington Pike and Shroyer and Stroop. Mr. York also addressed traffic signals at Stroop and Glenheath and Wilmington and Glenheath with no traffic through traffic. There is no way you can enforce that so why have the signs?
