POLICE BLOTTER

July 8, 2024

- 1501 hrs Officers conducted a traffic stop at 1112 Dexter Ave. The driver, **Joshua R. Staas (W/M/36)** was found to have a warrant through Mansfield PD for a CCW violation and was taken into custody after confirmation. **24-031826**
