### **December 2, 2024**

- 1438 hrs      Officers responded to 4440 Flowerdale Ave. Apt. F on a warrant service. Upon arrival, **Hunter N. Fields (W/M/29)** was placed under arrest on a confirmed warrant through Kettering for Failure to Appear on an original charge of Drug Paraphernalia **24-054905**
- 1843 hrs      Officers were dispatched to a disturbance at 526 Telford Ave. Apt. A. One of the subjects involved, **Kynnadie R. Holley (B/F/27)** was found to have an entered warrant out of Xenia Municipal Court for a Probation Violation and arrested after confirmation. **24-054929**
