**July 7, 2025**

- 0131 hrs. Officers responded to a report of a single vehicle accident near 2760 E. Rahn Rd. Prior to arrival the complainant advised a female involved in the accident fled the scene on foot southbound on Glenmina Dr. The female suspect was located nearby and was showing signs of impairment. **Julia M. Manasrah (W/F/29)**, was arrested for O.V.I. and later refused a breath test. **25-030109**
