- 1. This BZA application is to be filed with the Clerk of Council, City of Kettering Government Center, 3600 Shroyer Road, Kettering, OH 45429. Full applications with a properly signed application form may be submitted electronically at www.ketteringoh.org.
- 2. The required filing fee shall be in accordance with the City of Kettering Schedule for Permits, Inspections, Certificates and Fees payable at the time of application.
- 3. Attach the following information to the form:
  - a. All required exhibits in electronic pdf format. One (1) paper copy of the required exhibits, drawn to scale may be submitted if electronic is not available. This application will not be considered Complete until all exhibits and fees are submitted.
  - b. Any supplemental information which would be helpful to the reviewing body in making its decision.
- 4. The person making this application must sign at the end of this application form for this form to be complete. If the applicant is not the property owner, than a separate Appointment of Agent Form must accompany this application. The Appointment of Agent form must include the notarized signature of at least one of the owners of the property that is subject to the submitted application.

Your application will be assigned a case number, and you will be advised in writing as to the date your case is scheduled for a hearing before the Board of Zoning Appeals.

A complete application form and all required exhibits must be filed a minimum 13 working days before the BZA meeting held on the second or fourth Monday of each month. The City of Kettering reserves the right to postpone the public hearing if the application is incomplete or if there are not sufficient cases or a quorum does not exist.
