



# City Council Presentation Kettering Fire Department Modernization Strategy August 12, 2014






The City of Kettering will break ground this fall on the first of four proposed new fire stations. Construction on the station located at 3484 Far Hills Avenue will begin in coming months with anticipated completion by the end of 2015.



The new stations were sought as a result of a strategic planning process which began in 2006, and resulted in a comprehensive modernization strategy for all aspects of the Kettering Fire Department.

The new stations will provide appropriate facilities for the storage and safety requirements of modern apparatus, as well as modern facilities to accommodate 24/7 operations.

There is a difference in today's total project investment as compared to the original project estimate. The difference can be attributed to several factors:

 The early project budget and estimate was derived from the Architectural Resources Corporation report commissioned in 2012. ARC projections utilized year 2010 dollars and did not include inflation.





 Early estimates also included a range of stations as small as 2 apparatus bays and up to 4 bays. Our analysis demonstrated that 2 bay stations did not meet our modern service needs, thus we are proposing 3 stations having 4 bays and 1 station having 3 bays.




- In addition, early estimates were for the fire station facilities only. They did not include building design, equipment costs, land aquisition or site preparation.
- We are investing in several systems that have a higher initial investment, but will provide long term cost savings. These systems were not included in the original 2012project plan.



- A number of necessary emergency back-up systems were added that early estimates did not include. These systems include back-up dispatch for Public Safety and Public Service departments, back-up IT capabilities and an Emergency Operations Center. These systems are critical in maintaining our all hazards mitigation response model.
- We are also proposing that we move Fire Headquarters to the David Road location to enhance operational efficiencies and reduce personnel costs.

- Hempstead 2016 Station Completion (Station 36)






