Communications and Reports

Audience Participation (5 Minute Limit per Speaker)

Don Walls 2098 Springmill Rd.- He is here in support of Issue 36 that is on the ballot. The Charter Review Committee consisted of 13 people from various backgrounds. The Charter states that every 10 years, the Mayor must appoint a committee to take a look at the Charter to see if any changes need to be made. After spending numerous hours reviewing the Charter, the Charter Review Committee was able to come up with seven recommendations that needed to be changed:

- 1. Residency
- 2. Notice of Public Meetings
- 3. Definition of Elector
- 4. Updated the name to the Parks, Recreation, and Cultural Arts Advisory Board
- Clarity on the language of the role of who can appeal decisions concerning Planning Commission and the Board of Zoning Appeals
- 6. Gender Neutrality
- 7. Term Limits

Committee members spent many hours discussing term limits, and they also looked at what policies other communities have concerning term limits. Every time the Charter Review Committee met, they asked themselves what would be best for Kettering residents. They proposed extending term limits so there would not be a period of time that Council would have all new members. He encourages residents to vote this election, and he also encourages people to vote Yes on Issue 36 and No on Issues 31-35.

Sterling Abernathy 4951 Walnut Walk- He mentioned if Issue 36 passes it would eliminate the term limit for the Mayor, and it would extend existing term limits for City Council members from 8 years to 12 years. In July, after the Charter Review Committee made recommendations to Council, the Chairperson spoke about term limits. He had mentioned that some members of the Committee wanted to throw out all term limits, and some wanted to respect and keep some term limits. What was missing from that statement were the members who wanted to keep all term limits. Four years prior, 17,089 voters in Kettering voted to put term limits into place. That was 62% of people who voted in that election on that issue. The Committee was picked by the Mayor, and was not a good representation of the people in Kettering. Their meetings were kept quiet, and they did not invite the public to come and comment on the recommendations they were proposing. He urged residents to vote No on Issue 36.

Jacque Fisher- 4600 James Madison Trail- She mentioned she served on the Charter Review Committee, and they had a lot of discussion about term limits. She is proud to have an Issue 36 sign in her front yard. She mentioned Issue 36 followed a democratic process. As a group, the Charter Review Committee came together despite some of them having opposing opinions, to make a recommendation to Council about proposed changes to the Charter. She urged residents to vote Yes on Issue 36.

COUNCIL COMMITTEE REPORTS

Mr. Duke reported:

- He thanked Mr. Schwieterman for having staff be prepared for Kettering Leadership Academy Government Day.
- · He offered his condolences to Ray Keyton's family.
- He encouraged residents to vote for Issue 36, and to go to the City's website to get more information about the ballot issues.

Mr. Klepacz reported:

- He mentioned Vice Mayor Scott did a great job this evening!
- On October 13 he attended the ribbon cutting at State Farm.
- On October 13 he attended Kettering Leadership Academy Government Day.
- · He thanked business for choosing Kettering.

Mrs. Schrimpf reported:

- She mentioned Vice Mayor Scott did a great job!
- On October 17 she attended the ribbon cutting at the library on Far Hills Avenue.
- She mentioned that on October 26 Montgomery County will be opening a Business Solution Center at 1435 Cincinnati Street.
- She thanked the Charter Review Committee for all of their hard work.

Mr. Lautar reported:

- He seconded Mrs. Schrimpf comment about the ribbon cutting at the library on Far Hills on October 17.
- On October 17 he attended the Employee Service Awards.
- He seconded Mrs. Schrimpf comment on the Charter Review Committee.

Mr. Scott reported:

- He mentioned he has been receiving a lot of phone calls about the Charter Amendments. When he ran for Council 5 years ago, he ran on a platform of implementing term limits and cutting Council pay. He is a supporter of term limits, but he feels that the process taken to get Issues 31-35 on the ballot were performed in an improper manner. Having an experienced Mayor lead this City is vital, and Mayor Patterson is doing a great job. He is a personal supporter of Issue 36 and he supports the people who served on the Charter Review Committee. He mentioned he will be voting Yes on Issue 36 and No on Issues 31-35.
- He encouraged residents to vote on November 8.
- On November 11, 2016 there will be a Veterans Day dedication.

Mr. Wanamaker reported:

- He mentioned he agreed with Mr. Duke and Mrs. Schrimpf on their comments.
- He mentioned the Fire Department did a wonderful job hosting the community open houses.

Mayor Patterson reported:

Absent.
