KETTERING CITY COUNCIL REGULAR MEETING MINUTES November 8, 2016

The Council of the City of Kettering, Ohio, met in regular session on Tuesday, November 8, 2016, at 7:30 p.m. in Council Chambers at the Kettering Government Center South Building, 3600 Shroyer Road. Mayor Patterson presided and the Clerk of Council, LaShaunah D. Kaczynski, recorded. This meeting was telecast live on the cable access channel.

Mayor Patterson led the audience in the Pledge of Allegiance and gave the invocation. He introduced the cable TV operators Earl Jones and Liberty Lord. He thanked them for their assistance.

APPROVAL OF MINUTES

October 25, 2016- Council Meeting & Workshop Minutes

Mr. Duke reported that he reviewed the above minutes and moved the minutes be approved. Mr. Wanamaker seconded the motion and there being six (6) yea votes and no (0) nay votes for the October 25, 2016 Council Meeting & Workshop Minutes, the motion was declared carried by roll call vote.

PROCLAMATIONS, SPECIAL PRESENTATIONS, AWARDS, SPECIAL RESOLUTIONS, APPOINTMENTS TO BOARDS AND COMMISSIONS

Appointment- Board of Zoning Appeals- Patricia Higgins (Term ending 12-31-16)

Mr. Klepacz made a motion to appoint Patricia Higgins to the Board of Zoning Appeals. Mrs. Schrimpf seconded the motion followed by an unanimous like sign vote.

PUBLIC HEARINGS

P.C. 16-017- Request for a Zoning Map Amendment to rezone the properties comprising the Kettering Medical Center Campus and Moraine Farm from R-E (b), Residential Estate B District to an IS, Institutional District (Subject properties are located near the northwest quadrant of the intersection of Stroop Rd. and Southern Blvd.)

Mayor Patterson opened the public hearing and asked that any person that intends to speak to City Council about this matter should stand and take an oath. Those that planned to speak took the oath.

Tom Robillard, Director of Planning & Development gave the staff presentation this evening. This particular case involves the redevelopment of the Kettering Medical Center Campus and the Moraine Farm area. This will rezone the property from R-E (b) to IS (Institutional), which is a new zoning category that was created during the recent Zoning Code update. This was done primarily to accommodate Kettering Medical Center. There are seven factors that City Council is asked to look at:

- 1. Consistency
- 2. Adverse impacts on neighboring land
- 3. Public policy
- 4. Size of tract
- 5. Land presently zoning suitability
- 6. Healthy, safety, welfare
- 7. Other factors to take into consideration

Planning Commission did review these factors when they reviewed this application. This will change the current permitted uses, but it will not change the current development plan nor the current site and architectural requirements for the Kettering Medical Center. Planning Commission has recommended approval of this zoning.

Mayor Patterson informed Mr. Robillard that he had two questions. The first question he has was he wanted to clarify that this is a direct reflection of the Zoning Code revision? Also, he wanted to clarify that Planning Commission did vote unanimously (5 to 0) to approve this zoning?

Mr. Robillard informed Mayor Patterson that both of those statements are correct.

Merle Wilberding- 1013 Rubicon Rd made the applicant presentation this evening. He is here on behalf of Kettering Medical Center. He appreciates the opportunity to make a presentation this evening. He mentioned he would adopt Mr. Robillard's presentation this evening. This zoning will bring Kettering Medical Center and Kettering College into permitted uses under the Zoning Code revision. The zoning will accommodate the pattern district development for the hospital that was already approved. The overall property in the zoning area is about 120 acres. He mentioned he is very proud of the Kettering Medical Center for being in this community for 50 years. It is in great public interest that the City adopts this Ordinance.

Mayor Patterson asked if there were any other comments from the public either for or against concerning this public hearing. None were heard.

Mayor Patterson closed the public hearing and explained Council will consider legislation regarding this matter at a future Council meeting.

P.C 16-029- Request for Vacation of a portion of right-of-way for an overhead walkway between buildings (Subject properties are located at 3535 and 3700 Southern Blvd.).

Mayor Patterson opened the public hearing and asked that any person that intends to speak to City Council about this matter should stand and take an oath. Those that planned to speak took the oath.

Tom Robillard, Director of Planning & Development gave the staff presentation this evening. This involves the Kettering Medical Center campus in regards to a vacation of a small portion of right-of-way along Southern Blvd. The walkway will be 25x100 ft. long underneath the pedestrian bridge that connects the east and west side of the campus. This will help facilitate the connection between the east side and the west side of the property. This will combine the campus as a whole, instead of two separate properties divided by the public right-of-way. This will also allow Kettering Medical Center to provide better service. Planning Commission recommends approval of this vacation of right-of-way.

Merle Wilberding- 1013 Rubicon Rd made the applicant presentation this evening. He is here to represent Kettering Medical Center. He mentioned he will adopt Mr. Robillard's presentation this evening. This vacation of right-of-way will help memorialize the ownership of the walkway, and it will tie the two campuses together. This change will also help improve the hospital's insurance. He had a chance to review the record plans to make sure the City has reserved the right easements for utilities.

Mayor Patterson asked if there were any other comments from the public either for or against concerning this public hearing. None were heard.
