POLICE BLOTTER

Monday, January 22, 2018

- An officer was dispatched to S. Dixie and W. Dorothy for a suspicious person walking in the roadway. Upon contact with Donna M. Smith (B/F/47), she did not comply with orders and ran from the scene. After a short foot pursuit, Smith was arrested for Obstructing Official Business. She was transported to KPD Jail without incident. 2018-3401
- An officer responded to the KPD Lobby and took custody of M. Banning (W/M/37). Banning had turned himself in after assaulting his live-in girlfriend at 4629 Far Hills Av. Apt. 8B. Due to prior convictions, the DV was a felony. He was booked into the KPD Jail without incident. 2018-3374
- An officer stopped a vehicle on Dorothy Ln. near Woodman for a registration violation. Upon investigation and a consent search, suspected methamphetamine was found on the driver's person and a large quantity of marijuana and materials to make "dabs" were found in the trunk (beakers, pans, butane etc). Ren J. Benning (W/M/33) was arrested for possession of drugs and paraphernalia, and transported to KPD jail. 2018-3460
- An officer conducted a traffic stop at Burr Oak and Leonora on a reported intoxicated driver leaving a business in Beavercreek. The driver, Tonetta L. Costello (W/F/52) was under the influence of alcohol. Costello failed the field sobriety tests and was arrested for OVI. 2018-3479

Numerous attempts were made to get someone to come to the door but they were unsuccessful so officers forced entry.
