POLICE BLOTTER

Monday, February 5, 2018

1516 Officers were dispatched to Glenheath and Hemphill on a suspicious object. Upon investigation, they found what appeared to be an explosive device in a yard near the intersection. The Dayton PD Bomb Squad responded and collected the device. The device was destroyed at Moraine Farm and the remnants were collected as potential evidence. 2018-5880

1816 Officers responded to 1481 Tabor Ave. Apt. A, on a reported family problem. Upon investigation, it was learned that Donald B. Honeycutt had slapped and choked his live-in girlfriend (and mother of his child). Honeycutt was arrested for Domestic Violence and transported to KPD Jail without incident. 2018-5907

0024 An officer stopped a vehicle at Cordell and Hillwood for failing to stop at the sidewalk when leaving private property. The vehicle continued slowly for about two blocks before stopping. Investigation revealed the driver was concealing a plastic bag partially in his rectum, which he voluntarily produced; advising the crystal material inside was cocaine. Anthony S.
