## **POLICE BLOTTER**

### Monday, February 12, 2018

- An officer conducted a traffic stop near 2115 E. Dorothy Ln. for an equipment violation. Investigation revealed that Charles R. Thorton (B/M/43) was in possession of suspected methamphetamine, crack cocaine, marijuana, and a scale. Thorton was arrested for Possession of Drugs and Possession of Drug Paraphernalia. He was transported to KPD Jail without incident. 2018-7037
- 1727 Crews were dispatched to 916 Fairacres on a Personal Assist. Upon their arrival, they located Jessica M. Myers (W/F/36). Myers was intoxicated and unable to care for herself. She was uncooperative and would not find anyone to take custody of her. Myers was arrested for Disorderly Conduct / Public Intoxication. She was transported to KPD Jail without incident. 2018-7042
- 2005 Officers went to 1455 Willamet on a warrant service. Upon their arrival they arrested Adam Z. Johnson, w/m 33, on confirmed Dayton Warrants. 18-7061
- 0027 Officers responded to the UDF at 2200 E. Dorothy Ln for a possible intoxicated male. They located Obet Jennings Jr (B/M/56) and confirmed he was unable to care for himself. He was arrested for Public Intoxication and transported to KPD without incident. 2018-7103

- 1739 Officers attempted a warrant service at 5520 Kettering Square Drive South. Jasamine L. Brown, B/F/31, was located and arrested for an original warrant for the charge of assault. Brown was transported to the Kettering Jail. 2018-1961
- 2233 Officers were dispatched to 2935 Purdue on the report of a Family Problem. Upon their arrival, they located Russell W.L. Kunkle (W/M/35). Kunkle fled the scene on foot but was captured after a brief foot pursuit. Kunkle had an active warrant through Dayton for Obstructing Official Business and Resisting Arrest. The warrants were confirmed and Kunkle was taken into custody. A search incident to arrest revealed he was in possession of a syringe. He was additionally charged with Obstructing Official Business and Possession of Drug Abuse Instruments. He was transported to KPD Jail without incident. Additional investigation revealed Kunkle had missed court on 2/12 at Montgomery County Common Pleas Court and an additional warrant that had not yet been entered for felony possession (cocaine) was confirmed by MCSO. That warrant arrest was added to the list of charges. 2018-7277
- An officer conducted a traffic stop on Woodman Dr near Patterson. Upon speaking to the driver, Jody M. Boram Jr (W/M/28), marijuana was observed in plain sight. In Borams' coat pocket was later found a baggie of methamphetamine. He was arrested for F5 possession of drugs. 2018-7985

She was arrested for the warrant, issued a summons for Falsification, issued citations for DUS, Providing False Info to Avoid Citation and Failure to Maintain Continuous Lanes. 2018-7471

- 0710 Officers responded to 1901 W Stroop to assist Moraine PD on a Sig 10, in which one of the vehicles was reported stolen. The suspect fled on foot prior to the officers' arrival, and was last seen in the neighborhood of Hoyle & Fulton. Another officer also checked the area in his unmarked vehicle and found a subject matching the description. Crews arrived to assist, & further investigation revealed the subject had stolen the vehicle. The suspect, Nicole A Bolden, w/f, 39, was arrested for Auto Theft, and transported to KPD Jail where she was interviewed by the detectives. 2018-7487
- 1030 An officer responded to Greene Co Jail to pick up a subject in custody on our warrant. Shannon L Cochran, w/f, 23, was arrested for the FTA warrants (original charges of drug possession & drug paraphernalia), and transported to KPD Jail. 2017-30535

White, W/F/21, was contacted and initially stated Cotterman was not there. Laddie Baker, B/M/47, then stumbled up the basement stairs as officers were going to search the basement. Baker was found to very intoxicated and is Cotterman's father. Baker stated Cotterman was upstairs. Baker was arrested for disorderly conduct/public intoxication. White then admitted that Cotterman was upstairs. White was also observed by an officer attempting to conceal a marijuana pipe located in the kitchen. Officers searched upstairs and found Cotterman hiding in a

bedroom closet. Cotterman was arrested for criminal trespass and obstructing official business. White was issued a summons for possession of drug paraphernalia (marijuana). 2018-7732

0001 An officer conducted a traffic stop on Dorothy at Winding Way for an equipment violation. The driver, Christopher B. Shaffner (W/M/31) provided consent to search the vehicle. A capsule with suspected cocaine was located under a seat cushion, along with additional drug paraphernalia inside a purse belonging to the passenger, Emily B. Kujat (B/F/30). Shaffner was arrested for possession of drugs. Kujat was initially taken into custody on possession of drug paraphernalia (gel cap) and transported to the jail. Shaffner informed officers that he believed Kujat concealed additional contraband down the front of her pants when the traffic stop was initiated. Kujat denied the claim, but was caught attempting to dispose of another gel capsule in the rear passenger compartment of the cruiser and attempting to hide a small black bag (identified by Shaffner) which contained suspected heroin, cocaine, and drug abuse instruments in the jail. Kujat was also charged with drug possession, illegal conveyance, and tampering with evidence. 2018-07789
