POLICE BLOTTER

Monday, March 5, 2018

- 0800 An officer was sent to 3824 Roslyn Dr. to assist the medics on a possible dead body call. Shortly after his arrival, the medics pronounced **Tammy L. Hale, w/f/60**, dead at the scene. There were no suspicious circumstances as the decedent suffered from several health issues. The coroner's office was contacted and released the body to the family. **2018-10818**
- 1500 Crews were sent to 2121 Gay on the report of a burglary in which the suspect had just fled the residence. Officers located the suspect, **Kevin D Grindle, W/M/40**, and arrested him for Burglary and Possession of Drug Abuse Instruments. He was transported to KPD jail. **18-10898**
