VACATING PART OF A UTILITY EASEMENT IN THE ROSEWOOD GARDENS PLAT

WHEREAS, on February 5, 2018 the Planning Commission in Case No. PC-18-001 considered and recommended approval of an application to vacate part of a utility easement in the Rosewood Gardens Plat, Section One; and

WHEREAS, on February 27, 2018, this Council held a public hearing on the application and Planning Commission's recommendation and during the public hearing no party came forward in opposition; and

WHEREAS, this Council is satisfied that there is good cause for the vacation, that the vacation will not be detrimental to the public interest, and that such vacation should be made:

NOW, THEREFORE, Be It Ordained by the Council of the City of Kettering, State of Ohio:

Section 1. Approval is hereby granted for the vacation of a 5' wide, 120' long utility easement, as depicted in the attached Exhibit A, on north side of Lot 103 of the Rosewood Gardens Plat Section One, recorded in Plat Book PP, Page 52 of the plat records of Montgomery County, Ohio.

Section 2. The Clerk of Council is directed and authorized to prepare a certified copy of this Ordinance, and the Planning and Development Director of this City is hereby directed and authorized to accept the certified copy of this Ordinance from the Clerk of Council and, upon satisfaction of all Planning Commission conditions, if any, to further cause that same certified ordinance and any other necessary documents to be properly delivered to the Montgomery County Recorder for appropriate recordation. The City Manager is authorized to sign any instruments necessary to effectuate the vacation.

<u>Section 3</u>. This Ordinance shall take full effect from and after the earliest period provided by law.

Planning Commission hereby certifies that a public hearing was held at their meeting on February 5, 2018 and then again on March 19, 2018. While a decision made after the initial public hearing, due to concerns about adequate public notice, a second public hearing was opened at the March 19th Planning Commission meeting. A decision was reached after the public hearing was closed at the second meeting.

Planning Commission hereby submits its recommendation to Council that the requested Zoning District Map Amendment be approved.

Vote of the Planning Commission

The motion recommending approval was passed by a vote of 4:0.

Reason for Request

This request involves the rezoning of three pieces of land that are located at the NE and SW corners of E. David Road and Hempstead Station Drive. One of the properties is currently owned by the City of Kettering and contains the Fire Headquarters/Station #36, as well as about 4.5 acres of vacant land. While the address of this property is 4745 Hempstead Station Drive, primary access for additional development will likely be off of Glenstead Drive once the site is fully developed. The other principal property included in this request is the School of Advertising Art, which is located at 1725 E. David Road. This two year vocational school will soon be renamed the Modern School of Design, as the owners transition this educational facility into a four year college offering a Bachelor Degree program. A third parcel is the northeast corner of E. David and Hempstead Station, where a Vectren owned natural gas sub-station is located. Two of the properties are zoned ED-3 and the Vectren property is currently zoned I for Industrial use.

The Planning Commission made findings in their approval motion that all required standards for the proposed rezoning have been met.

Planning Commission hereby submits its recommendation to Council that the requested Zoning District Map Amendment be approved.

Vote of the Planning Commission

The motion recommending approval was passed by a vote of 4:0.

Reason for Request

This case involves a request to rezone a single residentially used lot from B - Business to R-2 (Neighborhood Residence). The R-2 designation already exists for adjacent properties north, west and east; which all contain homes on lots similar in size to the subject property. The lot to the south, like the subject property is also currently zoned B - Business. According to the owner/applicant, potential buyers have experienced difficulty getting a mortgage loan for the acquisition of the residence on the subject lot due to its commercial zoning designation. The current owners have decided that to consummate a sale of their home they wish to downzone the lot from B- Business to R-2, a single-family residential designation. To evaluate this financing dilemma, staff contacted a couple of mortgage and appraisal companies and they confirmed that many banks now either avoid mortgage loans on such properties or make the terms or restrictions so burdensome that a borrower is compelled to look elsewhere for financing. Many such potential buyers ultimately just pass on the purchase of commercially zoned residential properties.

The Planning Commission made findings in their approval motion that all required standards for the proposed rezoning have been met.
