The Council of the City of Kettering, Ohio, met in regular session on Tuesday, February 27, 2018, at 7:30 p.m. in Council Chambers at the Kettering Government Center South Building, 3600 Shroyer Road. Vice Mayor Lautar presided and the Clerk of Council, LaShaunah D. Kaczynski, recorded. This meeting was telecast live on the cable access channel.

Mr. Scott reported that he reviewed the above minutes and moved the minutes be approved. Mr. Duke seconded the motion and there being six (6) yea votes and no (0) nay votes for the February 13, 2018 Council Meeting & Workshop Minutes, the motion was declared carried by roll call vote.

PUBLIC HEARINGS

P.C. 18-001- Request for vacation of unused utility easement- 3216 Delaney Street.

Vice Mayor Lautar opened the public hearing and asked that any person that intends to speak to City Council about this matter should stand and take an oath. Those that planned to speak took the oath.

Tom Robillard, Planning & Development Director, gave the staff presentation this evening. This case is concerning an unused utility easement at 3216 Delaney Street. In this particular case, there is a 5' easement on the side of the property. There are no existing utilities within the easement, and there is no objection from utility providers for this vacation. The vacation would allow the property owner to construct a new detached garage in his rear yard 3' from the northern side of his lot line. This will be in compliance with the Zoning Code. The location is on Delaney Street. The plat is west of the Rosewood Arts Centre, and the property owner would like to construct his garage within the required set back of the Zoning Code which will encroach on the easement. There are no utilities and there were no objections. He believes that this is in order. Planning Commission held a public hearing and felt this case is in order, with recommendations to City Council for approval. He would be happy to answer any questions.

Dennis Wahle, 3216 Delaney Street- He mentioned he does not have anything to present, but he is here this evening to answer any questions from Council regarding this project.

Mr. Klepacz asked when is construction expected to begin assuming this passes?

Mr. Wahle mentioned that construction will begin in late spring around May or June.
