- TAKE FIRE PORTABLE RADIO AND CHARGER
- IF SAFE TO DO SO, IMMEDIATELY PROCEED TO MORAINE PD

POLICE POSITION 1 RESPONSIBILITIES

- CONTACT ON-DUTY ROAD SUPERVISOR OF THE NEED FOR EVACUATION
- PLACE BOTH CELL PHONES AND CHARGERS IN THE EMERGENCY GO BOX.
- TAKE THE DISPATCH EMERGNECY GO BOX WITH YOU. (BOX WILL INCLUDE DISPATCH CARDS, UNUSUAL OCCURENCES MANUAL, AND OTHER MISCELLANEOUS THINGS ALONG WITH A COPY OF THIS SHEET WITH THE BELOW IMPORTANT NUMBERS)
- TAKE THE POLICE PORTABLE RADIO AND CHARGER

- NON-EMERGENCY PHONES LINES AND 9-1-1 LINES MAY BE TEMPORARILY ROUTED TO
 CELLPHONES OR OTHER LINES BY CALLING THE AT&T RESOLUTION CENTER. THERE WILL BE THE
 2 KPD CELL PHONES AND OTHER LINES AVAILABLE AT MPD IN WHICH TO ROUTE CALLS.

- SWITCH 9-1-1 PHONE SYSTEM TO THE RDC IN CASES WHERE BOTH OUR 911 AND MPD'S 911
 SYSTEMS HAS GONE OFF LINE. (SWITCH IN DISPATCH MAIL ROOM)
- KEEP IN MIND THERE MAY ALSO BE SITUATIONS WHERE A PARTIAL EVAUCATION MAY OCCUR.
 AN EXAMPLE MAY INCLUDE FALURE OF KPD'S 911 SYSTEM WITH ALL OTHER DISPATCH SYSTEMS INTACT. THIS COULD MEAN 1 DISPATCHER REPSONDS TO MPD TO ANSWER 911 CALLS WHILE THE OTHER 2 REMAIN AT KPD.
- MORAINE PD IS COMPLIANT WITH STATE PSAP STANDARDS. ALTHOUGH SPACE WILL BE LIMITED WE CAN OPERATE OUT OF THAT LOCATION FOR EXTENDED PERIODS OF TIME.
- O IF WE ARE UNABLE TO IMMEDIATELY MOVE BACK TO THE KETTERING COUMMUNICATIONS CENTER WE WILL OPERATE OUT OF MORIANE PD. DISPATCHERS WILL REPORT TO MPD AT THE START OF THEIR SHIFTS AND CONTINUE TO DO THIS UNTIL THE KETTERING COMMUNICATIONS CENTER IS BACK ONLINE. SUPPLIES CAN BE BROUGHT TO MPD WHEN NEEDED.
