## **III. Operational Procedure**

- A. Officer safety considerations is priority
  - 1. Advise dispatcher of location prior to exiting vehicle
  - 2. Call for and wait for back up when dealing with multiple suspects
  - 3. Observe suspicious subject's body language
  - 4. Keep subject in sight and control his movements
  - 5. Anticipate potentially dangerous situations-may handcuff for officer safety but must communicate such
  - 6. Pat and frisk if requirements met (D below)
  - 7. Use interview stance (Defensive Tactics)
    - a. Keep gun hand free
  - 8. Move dangerous objects from subject's reach
  - 9. If possible do not violate subject's personal space
  - 10. Be cognizant of obvious signs of possible communicable diseases
    - a. Emaciated appearance
    - b. Unusual body odors
    - c. Skin eye discoloration

- d. Open lesions--sores, needle tracks, etc.
- e. Profuse sweating, coughing, raspy breathing
- B. Requirements for an FI
  - 1. Individuals may not be stopped for sole purpose of making out a FI
  - 2. Officers may make stop in following situations
    - a. Subject is observed committing an offense
    - b. Reasonable grounds to believe a subject has committed a theft offense or offense of violence not in your presence
    - c. Possess or is aware of existence of a warrant for subject
    - d. Reasonable suspicion of criminal activity
- C. FI cards should list the following
  - 1. Reasonable suspicion must be based on specific, articulated and objective circumstances
  - 2. Examples
    - a. Furtive gestures
    - b. Attempt of concealment
    - c. Late hours
    - d. High crime area
    - e. Match description of suspect
- D. Circumstances or situations that warrant pat down and frisk
  - 1. Subject matches description of suspect from offense in which there was violence, weapon displayed and/or used
  - 2. Subject attempts to keep one side of his body turned away from officer
  - 3. Unusual bulges or outlines of objects under clothing
  - 4. Subjects wearing long or heavy clothing not consistent with weather
  - 5. Subject touching or patting outer part of clothing
  - 6. Subject attempts to distract officer's attention
  - 7. Subject keeps trying to put hands in pockets.
