Audience Participation (5 Minute Limit per Speaker)

Ellen Miller- 3014 Kingston Avenue- She is here this evening to express her concerns about a problem home in her neighborhood (3006 Kingston Avenue). This home is abandoned, but it is now bank owned. Over the winter months, there were squatters living at this residence and they did not have trash service. Once they left the residence, they threw their trash in the basement of this home. There are approximately 20-60 bags of garbage in this basement. When the bank obtained ownership of the home the locks were changed. She has only seen the realtor of this property once. When the realtor opened the doors to the home, the odor was very powerful due to the trash in the basement. If you walk to the side of the home, you can see garbage that is piled up from the side window. The city is aware of this problem, but she was told the city can't do anything about this because the garbage is not visible from the street. This is a health problem and she has contacted Montgomery County Health Department regarding this issue. She was told by the county that they would have to go to court and get a court order to be able to enter this home. She feels those steps need to be taken by the county because this is a public health hazard. There could be rats in the basement of this home, and rats carry diseases and fleas. There are also other insects inside of that basement and the problem is getting worse. This has been going on since March. The house is completely sealed up and that is locking up the smell of the garbage. She feels like her home does not hold any value being located next to this problem home. She would like to put her taxes in an escrow account and when the city decides to do something about this problem she will pay her taxes. When the house is finally opened up, all of the insects and smell will come out of the house. No one cares about this problem because nothing is being done to address this issue. She has placed plastic over her windows to keep the smell out of her home, and she shouldn't have to live like this. It is up to City Council to fix this problem because the entire neighborhood is at danger. There could be disease spreading from this home.

Mr. Scott asked if Ms. Miller remembers the name of the realtor who is over this home.

Ms. Miller informed City Council that the realtor is Mariana Graffalo who is a real estate broker and the city has contacted her. The city should have a nuisance abatement policy. The city is unable to do anything about this property because the trash is not visible from the street, but if there was a nuisance abatement policy in place this would be a great case for it.

Mr. Scott asked if Ms. Miller knows the name of the bank that has ownership of this property.

Ms. Miller informed City Council that the realtor would not tell her that information. She is also angry at the situation. It was irresponsible of the people who lived there to leave the house in that condition.
