KETTERING CITY COUNCIL REGULAR MEETING MINUTES November 26, 2019

The Council of the City of Kettering, Ohio, met in regular session on Tuesday, November 26, 2019, at 7:30 p.m. in Council Chambers at the Kettering Government Center South Building, 3600 Shroyer Road. Mayor Patterson presided and the Clerk of Council, LaShaunah D. Kaczynski, recorded. This meeting was telecast live on the cable access channel.

Mr. Scott reported that he reviewed the above minutes and moved the minutes be approved. Mr. Wanamaker seconded the motion of the above minutes and there being six (6) yea votes and no (0) nay votes for the November 12, 2019 Council Meeting & Workshop Minutes, the motion was declared carried by roll call vote.

PUBLIC HEARINGS

PUBLIC COMMENT ON LEGISLATION

Sterling Abernathy- He is here this evening in regards to item number 6 on the agenda which is an ordinance to make changes to the city's income tax laws. This ordinance is an emergency ordinance which means it will bypass the normal public notice and review periods. The city released this ordinance Friday afternoon and once it is approved this evening, it will become law immediately just four days after it was first released. This ordinance will be enforced before the public has become aware of it, has had a chance to read it, provide comment, or petition for a voter referendum. This is unlike regular ordinances which are announced and discussed at two separate council meetings which are two to three weeks apart before being adopted. So what is the tax law emergency? The ordinance says it is an emergency measure for the immediate preservation of public peace, health, and safety. This emergency is arising from the coercive provisions of law found in Ohio House Bill 49 section 718.04a of the Ohio Revised Code, and the need for the city to comply with the municipal income tax provisions and state laws. The ordinance mentions House Bill 166 which was passed by the legislature in July of 2019 which was four months ago, and House Bill 49 was passed in September of 2017. To comply with state laws that were passed two years ago and four months ago, the city is declaring this ordinance an emergency to run those tax changes through in just four days after being released. This ordinance this evening is not the first tax law that has been passed as an emergency in Kettering. In 2018, the city changed the tax law twice with the first occurrence happened in February and the second in November. Both were emergency ordinances from state laws being enacted months before the Kettering ordinances. Tonight will be the third time in a row that the city's tax law is being changed as an emergency and is being run through in four days. Tax laws are not the only emergencies. In the last two years, the city has had eleven emergency or expedited ordinances. All three ordinances on the agenda this evening are emergency ordinances caused by three different emergencies. Is the stated reason for the emergency correct and efficient? Is there an alternative to an emergency ordinance or could these ordinances been handled by using a regular ordinance that would not bypass citizen review? Did the city have enough time from when the related state laws were approved to do its ordinance without declaring an emergency? Changes to Kettering's laws should be done in sufficient notice and time to allow citizens to be informed and participate. Emergency ordinances cut citizens out of the law making process and emergency ordinances should only be used for actual emergencies that cannot be avoided.
