WHEREAS, Miami Township, Montgomery County, Ohio seeks to obtain additional police services from the City of Kettering in the form of dispatch services;

WHEREAS, the City of Kettering is willing and able to provide police dispatch services to Miami Township;

NOW, THEREFORE, Be It Resolved by the Council of the City of Kettering, State of Ohio, that:

Section 1. The City Manager is authorized to enter into the Agreement For Public Safety Dispatch Services, with Miami Township, attached hereto as Exhibit A. The City Manager is further authorized to sign any amendments or extensions thereto that the City Manager deems appropriate.

<u>Section 2</u>. As provided in Section 4-8 of the City Charter, this Resolution takes place immediately upon its adoption.

# AGREEMENT FOR PUBLIC SAFETY DISPATCH SERVICES BETWEEN THE CITY OF KETTERING, OHIO AND MIAMI TOWNSHIP, OHIO

This Agreement is entered by the City of Kettering, Ohio ("Kettering"), an Ohio Municipal Corporation, with principal offices located at 3600 Shroyer Road, Kettering, Ohio 45429, Miami Township, Montgomery County, Ohio ("Miami Township"), with offices located at 2700 Lyons Road, Miamisburg, Ohio 45342.

WHEREAS, Ohio Revised Code Section 737.04 authorizes the legislative authority of any municipal corporation to enter into a contract with a township, upon any terms that are agreed upon, for services of police departments; and

WHEREAS, Ohio Revised Code Section 505.43 authorizes a township to contract with municipal corporations, upon any terms that are agreed upon, for services of police departments; and

WHEREAS, Kettering is a charter municipality with constitutionally-granted home rule powers; and

WHEREAS, Miami Township seeks to obtain additional police services from the City of Kettering in the form of dispatch services ("Public Safety Services"); and

WHEREAS, the Kettering City Council on	, 2020 passed Resolution No,
authorizing this Agreement with Miami Township	for public safety services; and

WHEREAS, the Miami Township Board of Trustees on \_\_\_\_\_, 2020 passed Resolution/Ordinance No. \_\_\_\_\_, authorizing this Agreement with Kettering for purchase of public safety services; and

WHEREAS, it is the desire of Kettering and Miami Township to provide for public safety services in accordance with the terms and conditions set forth herein.

NOW, THEREFORE, in consideration of the foregoing and of the covenants and agreements herein contained, the parties, intending to be legally bound, agree as follows:

#### ARTICLE I -PUBLIC SAFETY DISPATCH SERVICES

A. Dispatch Services: Kettering, through its dispatch center located at 3600 Shroyer Road, Kettering, Ohio, ("Dispatch Center"), agrees to dispatch Miami Township Police Department calls, on a 24 hour, 365 days per year basis, to authorized personnel of the Miami Township Police Department and other public safety resources generally with regard to emergency and non-emergency incidents, and with communication support and services/systems directly related to the dispatch function ("Dispatch Services"). Dispatch

Services include but are not limited to the following:

- a. Radio communications;
- b. Telephone communications;
- c. Dissemination of emergency 9-1-1 calls;
- d. Law Enforcement Automated Data Systems (LEADS) and National Crime Information Center (NCIC) information, if appropriate;
- e. Teletype communications;
- f. Telecommunications for the deaf or hearing impaired;
- g. Recording of radio and telephone communications;
- h. Public Safety Inter-agency communications; and
- i. Operation of the Computer Aided Dispatch (CAD) system.

The Dispatch Services including processing of calls, to be made available and provided to Miami Township upon request and in a reasonable time period, shall be equivalent to those Dispatch Services that are provided to the City of Kettering.

- B. Dispatch Services Equipment: Kettering shall furnish all initial equipment necessary to provide the Dispatch Services to Miami Township, including but not limited to all initial base station radio equipment, furniture, consoles and telephone equipment directly related to dispatch functions, and shall routinely maintain such equipment in a reasonable manner. All decisions relating to the provision, maintenance, upgrading, and replacement of such equipment are and shall remain within the sole discretion of Kettering. However, the parties agree that any major capital expenditures which may impact Miami Township shall be approved by Miami Township prior to implementation.
- C. Miami Township shall provide all equipment necessary to receive the Dispatch Services in the field, including portable radios, mobile radios, mobile data terminals, incar radio equipment, video cameras and monitors, and any other communications equipment, and shall maintain and replace such equipment in a manner that ensures compatibility with Kettering's provision of Dispatch Services. Miami Township agrees to update and/or replace all equipment necessary to receive the Dispatch Services provided by Kettering as may be necessary to ensure the provision of Dispatch Services.
- D. Miami Township acknowledges that Kettering in the future may incur additional costs in upgrading, repairing, and replacing equipment necessary to provide the Dispatch Services for the benefit of Miami Township and other communities. Miami Township and

Kettering agree to negotiate, in good faith, their respective responsibility for any such costs for the benefit of Miami Township that are not reimbursed by grants.

- E. Miami Township shall be solely responsible to individually pay for its own user fees for such services as LEADS, CAD, RMS, or MDC airtime.
- F. Personnel: Kettering shall provide all personnel necessary to provide Dispatch Services to Miami Township. All staffing issues, including the number of Public Safety Dispatchers working at any given time, shall be determined by the Kettering Chief of Police. Kettering shall be solely responsible for the management of all Dispatch Center personnel and all personnel-related issues.
- G. In reliance on Miami Township's representations, promises, and covenants herein, including in the recital paragraphs, Kettering agrees that after the effective date of this Agreement and prior to the commencement of services date, it will increase the total number of Public Safety Dispatchers and civilian supervisors employed by Kettering as necessary within its discretion to handle the increased volume of dispatch activity generated as a result of this Agreement.
- H. Payment for Dispatch Services: Miami Township, in consideration of the provision of the Dispatch Services outlined herein, agrees to pay Kettering the amount of \$300,000.00 for the first year. For the second year and each year thereafter, Miami Township will pay Kettering an amount equal to the projected average annual salary and benefits of all full-time personnel providing Dispatch Services multiplied by three, plus 18.75% of any overtime costs incurred by Kettering in providing Dispatch Services during the previous 12 months. (For example, if the projected average annual salary plus benefits equals \$100,000, then the total annual payment would be \$300,000 (\$100,000 x 3 = \$300,000). If overtime costs were \$20,000 during the previous 12 months, then the total annual payment would be \$303,750 (\$20,000 x .1875 = \$3,750 + \$300,000 = \$303,375)). The yearly sum will be divided into four equal quarterly payments during each year this Agreement is in effect, with the first said quarterly payment due upon the Commencement of Services Date stated in Article II below and each succeeding payment in like amount being due on the same date of each quarter as billed by the City of Kettering.
- I. Financial Advisory Board: The parties agree to meet directly and/or through a Financial Advisory Board as appointed by each party by July 31st of each calendar year, or such other date as is mutually agreeable, to evaluate the sufficiency of payments for future Dispatch Services and to discuss in good faith any proposed changes, whether increases or decreases in user fees based on an operational cost analysis to include evaluation of costs distribution, changes in workloads, economies of scale and labor costs, and any unforeseen regulatory or mandatory costs not otherwise addressed herein.
- J. Operating Procedures/Operations: Control of operating procedures and operations for the Dispatch Center shall rest within the sole discretion of Kettering. Supervision and

management over the Public Safety Dispatchers personnel shall lie solely with the City of Kettering. Notwithstanding the above, the City of Kettering shall make all reasonable efforts in connection with its operation of the dispatch center to not materially interfere with the standard operating procedures, response protocols, or other internal operations of Miami Township or the other various individual contracting communities, if any. Further, the parties agree that they will work together in a cooperative, effective and efficient manner to promptly resolve any technical and/or operational issues arising under this Agreement. As such, the chiefs of police of the Parties, or their designees, will serve as liaison for handling any and all issues, complaints, concerns, or inquiries from the other party until a resolution is achieved.

K. Increased Workload Volume: If calls for service or incident volume directly related to Miami Township increases to a point that additional staffing becomes necessary, the City of Kettering, after obtaining approval from Miami Township, which approval shall not be unreasonably withheld, may increase quarterly fees. Notwithstanding, the parties further agree that the foregoing quarterly payments shall increase, as necessary, to cover any additional expenses that were not included in the total annual payment calculation, including contractual wage increases, health insurance increases, and other personnel-related costs, associated with Kettering's cost of employing the additional dispatch personnel necessary to provide Dispatch Services to Miami Township. Kettering shall notify Miami Township, in writing, of any such additional expenses at least thirty (30) days prior to the effective date of any such increase.

L. No Obligation to Respond/No Liability: This Agreement is not intended to and shall not be construed to require Kettering to respond beyond the dispatch function to calls or incidents, nor to otherwise provide law enforcement services in Miami Township. In this regard, Kettering shall have no liability or responsibility for the actions, errors, omissions, or negligence of the Miami Township Police forces or service personnel in responding to any dispatch calls taken through the Dispatch Center. Miami Township shall maintain proper levels of insurance in this regard. Notwithstanding this provision, Kettering may render assistance in accordance with Ohio law, any current mutual aid agreements, and/or any current agreements for dispatch services.

M. Rules and Regulatory Provisions: All radio operations shall be in accordance with the rules and regulations of the Federal Communications Commission. All LEADS and NCIC functions will be performed in accordance with rules and regulations of each. All other applicable rules and regulations of any state and national governmental agencies associated with the operations of law enforcement radio operations, computer terminals and operations, and databases shall be followed.

N. Insurance and Subrogation: Each party shall be responsible for maintaining liability insurance deemed appropriate by each. There shall be no indemnity between the parties for any liability arising out of an alleged act or omission by the other party, its agents or employees. Each party waives any right of subrogation on its own behalf and on behalf of its insurers.

#### ARTICLE II-TERMINATION

A. It is estimated that Kettering shall begin providing the Public Safety Services at twelve o'clock a.m. on \_\_\_\_\_\_, 20\_\_\_\_ or as soon thereafter as Kettering reasonably determines that all training, staffing, systems (including LEADS), and operational prerequisites are set in place and ready ("Commencement of Services Date"). In the interim, Miami Township shall continue to maintain their current dispatch services and shall provide necessary support to Kettering for transition efforts.

B. This Agreement shall remain in effect for an initial term of five years, with options to renew automatically for additional five year terms, subject to re-negotiation. If either party desires to terminate this agreement at the end of a five year term, that party shall give at least six months advance written notice of its intent to terminate. The parties agree to begin negotiations at least six months prior to the end of each five year term.

C. Notwithstanding the foregoing, if Kettering decides to stop providing Public Safety Services and procure them instead from a another entity, Kettering may terminate this agreement by giving at least six months advance written notice to Miami Township.

#### ARTICLE III-PUBLIC RECORDS

The parties agree and acknowledge that records created pursuant to this Agreement may be public records under the Ohio Public Records Act and agree to coordinate with each other, in a timely manner, on responses to public records requests and with regard to determination of records schedules retention periods and times for destruction. Notwithstanding this provision, the parties agree that nothing in this Article shall be construed as limiting a party from responding to a public records request in accordance with Ohio law. Processes will be established to enable Miami Township to obtain access to its recordings of radio and telephone traffic.

Any notice or communication shall be deemed effectively given (a) on the date of delivery, if delivered by hand or (b) on the date mailed if sent by overnight express delivery or U.S. Mail.

#### ARTICLE V- CERTIFICATION OF FUNDS

Ohio Revised Code Section 5705.41 requires Miami Township to certify that the funds necessary to pay for this Agreement have been appropriated and either collected or are in the process of collection. Miami Township and Kettering acknowledge and agree this Agreement may automatically renew, and does not provide for a specified final term or end date. Miami Township, in accordance with Ohio Revised Code Section 5705.41, will initially certify this Agreement for \$300,000.00 and shall re-certify this Agreement each year it is in effect for such amounts as may be required to ensure its respective obligations under this Agreement. Upon obtaining the appropriation of additional funds, the Agreement shall be re-certified by the Fiscal Officer of Miami Township; and a copy of the additional certification shall be provided to Kettering's Finance Director. Failure to certify additional funds, as required by this Agreement, shall be grounds for immediate termination of this Agreement.

#### ARTICLE VI- MISCELLANEOUS PROVISIONS

A. Entire Agreement: This Agreement represents the entire and integrated agreement between Kettering and Miami Township concerning the within subject, and supersedes all prior negotiations, representations, or agreements, either written or oral.

B. Modification of Contract: It is understood and agreed that this Agreement may not be

changed, modified, or altered except by an instrument, in writing, signed by duly authorized representatives of both parties.

- C. Counterparts: This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of such counterparts taken together will constitute one and the same Agreement. Copies of duly executed counterparts shall have the same legal effect as an original. Facsimile signatures or signatures transmitted by email or other electronic means shall be sufficient to bind the Parties.
- D. Assignment of Contract: Neither party shall assign, delegate, or subcontract any portion of the Dispatch Services without prior written express approval of the other party.
- E. Choice of Law/Forum: This Agreement shall be deemed made and entered into in the State of Ohio and shall be governed by and construed in accordance with the law of Ohio. Any litigation related directly or indirectly to this Agreement will be resolved in the appropriate court in Montgomery County, Ohio.
- F. Severability: If any provision of this Agreement, or any covenant, obligation or agreement contained here is determined by a court of competent jurisdiction to be invalid or unenforceable, such determination shall not affect any other provision, covenant, obligation or agreement, each of which shall be construed and enforced as if such invalid or unenforceable provision were not contained herein. Such invalidity or unenforceability shall not affect any valid and enforceable application thereof, and each such provision, covenant, obligation or agreement, shall be deemed to be effective, operative, made, entered into or taken in the manner and to the full extent permitted by law.
- G. Other Similar Agreements by Kettering: Nothing in this Agreement is intended to nor shall it serve to in any way to limit the sole and unfettered discretion of the City of Kettering to contract with other municipalities, townships, or political subdivisions for dispatch services and to establish appropriate fees for such purpose totally independent of the arrangement and fees determined for services provided under this Agreement. If, during the term of this Agreement, Kettering enters into any subsequent Public Safety Services agreement with any other political subdivision which has a similar population and the same call volume as Miami Township, and if the subsequent Public Safety Services agreement provides for more favorable terms or pricing than contained in this Agreement, then this Agreement shall be deemed to be modified to provide Miami Township with the more favorable terms or pricing, so long as Kettering is still able to recover all its costs of providing Public Safety Services to Miami Township. If the foregoing conditions are met, Kettering shall promptly notify Miami Township of the existence of such more favorable terms and/or pricing and immediately implement the more favorable terms and/or pricing.

H. Default: In the event either party fails to perform any of its duties hereunder, the non-defaulting party may elect to terminate upon the giving of thirty (30) days prior written notice. Upon termination, all rights duties, and obligations of both parties shall cease as to any future performance hereunder but each party shall remain liable to the other for payment of any money which is or becomes due to the other party prior to termination. Each party shall be entitled to the return of any property owned by it in the possession of the other. Should Kettering incur any unemployment costs related to the termination of this Agreement, Miami Township shall reimburse those costs.

I. Third Party Beneficiaries: Nothing in this Agreement, express or implied, is intended to or shall confer upon any other person any right, benefit or remedy of any nature whatsoever under or by reason of this Agreement.

From the General Fund: ECONOMIC DEVELOPMENT Operating Expenses \$3,600,000.00 TRANSFERS TO OTHER FUNDS State Highway Fund 62,000.00 B. From the State Highway Construction and Maintenance Fund: Street Surfacing 283,360.00 C. From the Special Grants & Programs Fund: Other \$ 2,370,569.80 Law Enforcement 15,000.00 Section 2. The Director of Finance is authorized to adjust appropriations within any fund or department as long as the adjustments made do not exceed the total appropriation authorized within that fund or department.
